Fixed Income: Auction Calendar

Re-opening of 20-year GII 8/43 prints BTC of 1.992x

Post-announcement, WI opened at 4.27/4.21% with total trades circa RM100m being printed between 4.28-27% area; before closing tighter at 4.28/26% area today. This auction saw a mere submission of bids at RM5.98b, resulting in a weak BTC ratio of 1.992x; similar as per its recent re-opening in May (with a BTC ratio of 1.747x). The total offering of RM5.0b (consisting of RM3.0 auction and RM2.0 private placement) was in line with our forecast. Summary of tender results were:

Bid to Cover: 1.992x High: 4.301% Average: 4.285% Low: 4.24% Cut-off: 62.50%

Although this 20Y GII auction disappointed in terms of demand metrics; we note slight positives in terms of relative valuation to equivalent GII and term premium taking despite the rather large outstanding issuance of RM15.5b...

The tail of 1.6bps reflected muted demand metrics with some participation seen mainly from insurance companies and inter-bank participants, The yield offered at 4.285% is ~10bps higher compared to its last equivalent auction which notched an average 4.182% in May. Nevertheless, we note the slight positive relative valuation for now taking cognizance of the historical annualized mean spreads between the generic Islamic and conventional 20Y benchmarks (unadjusted for duration) which is ~5-7bps (Note: the 20Y conventional benchmark equivalent MGS 10/42 was last done at 4.169% levels). From a term premium perspective, we find the 20Y sector offering relative value and adopt a neutral-to-slightly positive bias despite some reservations on liquidity factor. Up next is the re-opening of 15Y GII 6/38 with a projected issuance size of RM4.5b.
