Fixed Income: Auction Calendar

Re-opening of 15-year MGS 6/38 prints BTC of 2.201x

Post-announcement, WI opened at 4.09/4.04% and subsequently slipped lower to 4.05/4.00%. Total trades circa RM90m were printed between @ 4.03% and 4.025% levels; before closing levels, which were quoted tight at 4.03/02%. This auction saw total submission of bids at a RM6.603b, resulting in a BTC ratio of 2.201x when compared to its earlier re-opening in January with a BTC ratio 2.825x). The total offering consisting of RM4.5b was in line as per our forecast. Summary of tender results were:

Bid to Cover: 2.201x High: 4.033% Average: 4.023% Low: 3.990% Cut-off: 48.37%

This 15Y MGS auction saw strong demand from lifers and pension funds; relative value may be absent at this juncture but we opine that the 15Y sector remains slightly undervalued...

The mere tail of a mere 1.0bps reflected strong bidding metrics with demand mainly from insurance companies and pension funds. The yield offered at 4.023% is ~13bps lower compared to its last equivalent auction which notched an average 4.151% recently in January. Although reflecting fair value at present, one must take cognizance of the fact that the historical annualized mean spreads between the generic Islamic and conventional 15Y benchmarks unadjusted for duration is 4-5bps (Note: the 15Y Islamic benchmark equivalent GII 3/38 was last done at 4.01% levels). From a term premium perspective however, we remain positive on 15Y MGS/GII tenures. Up next is the reopening of 3Y GII 9/26 with a projected issuance size of RM4.5b.
