Intraday Thoughts – MYR Neutral to Bearish

USD/MYR opened 0.1% higher at 4.2430. A break of the 4.23 handle has increased bullishness in the pair but momentum indicators look neutral for now. We continue to eye a range of 4.21-4.25, monitoring the local political development. Any break of the 4.25 key resistance will pave the way towards 4.28 next.

1-Month Outlook – MYR Neutral

We expect the MYR to regain some lost grounds as higher vaccination rates should help better contain the pandemic situation. This would allow Malaysia to move on to the next phase of its National Recovery Plan and most importantly, allow more economic sectors to reopen and/or operate at higher capacity. We are forecasting USD/MYR to trend back to the 4.20 levels in the months ahead once the situation stabilizes and some forms of calm return, paving the way for more meaningful reopening and recovery in the final quarter of the year. Expectations for some consolidation in the USD would be supportive of the MYR too.

EUR/MYR opened 0.5% lower at 4.9619. USD bulls depressed EUR further, leaving the pair near 2021 low of 1.17. EUR/MYR followed suit amid a steadier MYR. The Eurozone's 2Q GDP growth was unrevised. The HICP inflation is up next in today's data docket.

GBP/MYR opened 0.6% lower at 5.8223. The sterling continued to weaken alongside other G10 currencies despite positive UK employment data yesterday. Watch out for today's CPI data of which a surge may further boost the expectations for a BOE tightening, although the central bank has brushed off any future temporary surge in prices.

AUD/MYR opened 0.5% lower at 3.0745. Australia's wage data turned out to be disappointing, adding to the woes from yesterday's RBA minutes amid a strong USD environment. AUD/MYR managed to bounce off its weakest 2021 level but momentum remained biased towards the downside.
