Intraday Thoughts – MYR Bullish

USD/MYR opened little changed at 4.2180 and weakened to as low as 4.2120 before recovering slightly to 4.2155. MYR is riding on the broad USD weakening and the end of political uncertainties on the domestic front. Momentum remained biased towards the downside for the pair, with the rally in commodity prices favouring the MYR. Pair may still attempt to breach 4.21 today before moving to key 4.20 support.

1-Month Outlook – MYR Neutral

We expect the MYR to regain some lost grounds as higher vaccination rates should help better contain the pandemic situation. This would allow Malaysia to move on to the next phase of its National Recovery Plan and most importantly, allow more economic sectors to reopen and/or operate at higher capacity. We are forecasting USD/MYR to trend back to the 4.20 levels in the months ahead once the situation stabilizes and some forms of calm return, paving the way for more meaningful reopening and recovery in the final quarter of the year. Expectations for some consolidation in the USD would be supportive of the MYR too.

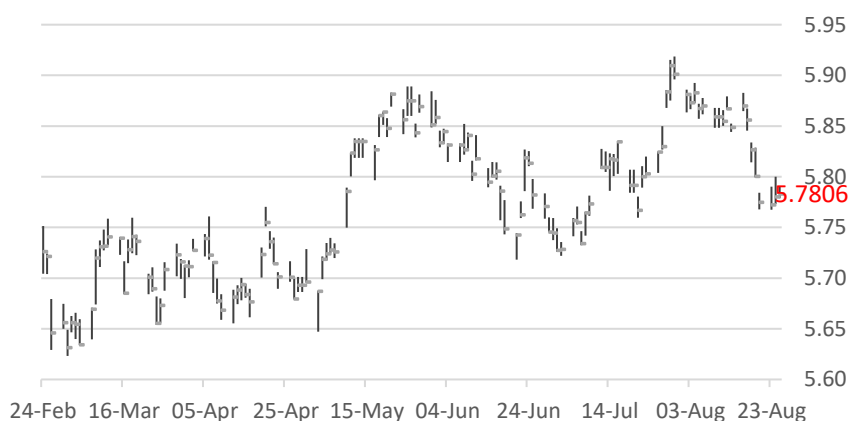


EUR/MYR Neutral to Bearish

EUR/MYR opened 0.2% higher at 4.9569. EUR/USD failed to maintain its one-week high of 1.1765, slipping back to circa 1.1740 as of writing. Germany's IFO business sentiment is set to be a key market driver today. Outlook remains neutral to bearish for EUR/MYR as MYR strengthened further, with immediate support at 4.9450.

GBP/MYR opened 0.1% higher at 5.7885. GBP/USD failed to break 1.3750 critical resistance and pulled back to circa 1.3700 as of writing. This should help keep GBP/MYR within a tight range, potentially flat-lining at circa 5.78 levels amid a lack of major driver.

AUD/MYR opened 0.3% higher at 3.0571. AUD/USD rallied alongside other commodity currencies overnight. USD softening may extend to today's session, boosting AUD recovery. Optimism surrounding potential reopening and the rebound in oil prices may continue to offer support as well.
