Intraday Thoughts – MYR Neutral

USD/MYR opened 0.07% higher at 4.3995. The extended retreat in broad dollar should continue to support the local unit today, likely keeping the pair within a tight range of 4.3900-4.4000 ahead of Fed Chair Powell’s congressional testimony. Higher Malaysia CPI print due this Friday would likely reinforce expectations for an OPR hike in July.

1-Month Outlook – MYR Neutral

We expect the MYR to recover some lost ground in the medium term; supported by the further economic recovery as the government reopened the Malaysian border on 1st April. Recent rally in global commodity prices coupled with increase in minimum wage to RM1,500 effective 1st May should provide an added impetus. Firmer growth outlook has resulted in a 25bps increase in the OPR by BNM at the May MPC meeting and we expect another 50-75bps increase for the remainder of this year. We have taken into account the broader USD which is supported by the larger than previously expected rate hikes by the Fed. On the flipside, the Russia-Ukraine crisis and China’s strict Covid policy could potentially derail recovery and policy normalization path.

SGD/MYR opened 0.13% lower at 3.1726. The rally in global risk assets has helped to support both EM currencies in the short term. Nonetheless, the cross continues to maintain its neutral tone heading into mid-week, trading at circa 3.1700 amid a lack of direct drivers as the market looks towards US related news and may be driven by resurging USD strength.

GBP/MYR



GBP/MYR Neutral

GBP/MYR opened 0.34% lower at 5.3953. The sterling registered only modest increase despite broad USD weakness, failing to keep up with higher gilt yields. While the change in forward guidance to a hawkish stance removes some uncertainty over the previously expected gap between the Fed-BOE rate hike cycles, the weaker showings of recent UK data suggested that the UK may be in a more difficult position to take rates higher further, thus limiting the GBP upsides.

AUD/MYR Neutral to Slightly Bearish

AUD/MYR opened 0.07% lower at 3.0619. Outlook is neutral to slightly bearish. The hawkish RBA minutes and additional signals from Governor Lowe for more rate hikes only gave AUD a temporary boost as global sentiment took a sour turn this morning amid renewed recession fear.
