Intraday Thoughts - Neutral-to-Slightly Bullish

USD/MYR opened 0.01% lower at 4.6357 before rebounding to 4.6420 at the point of writing. Daily outlook is neutral-to-slightly bullish on Dollar strength, and as the pair flirts around the oversold position at the point of writing. The pair will nonetheless face resistance at 4.6469 (R1) and 4.6537 (R2) levels this morning, as investors largely stay cautious ahead of crucial policy meetings and as well as slew of 1st tier data from the US this week, starting with the Conference Board's consumer confidence, JOLTS job openings as well as home prices today.

1-Month Outlook - USD/MYR Neutral-to-Slightly Bearish

The USD/MYR outlook is neutral-to-slightly bearish as the upside for the DXY appeared to have peaked, amidst cooling-but-still resilient signs of a labour market, forward looking data that suggests gradual weakening in economic conditions in 2Q. Nonetheless, Fed officials have repeatedly stressed the need for more good data on the inflation front, and as such, this should keep rate cut expectations and marked weakening in the Dollar, in check. Domestically, MYR will be supported by expectations for an extended pause in the OPR, as recovery in exports, sustained domestic demand and upside risk to inflation amid imminent subsidy cuts should shield BNM from any OPR cut.

USD/SGD opened flat at 1.3434 before strengthening to 1.3443 at the point of writing. We prefer to stay neutral for this pair today as it appears to face strong resistance at the 1.3447 level, and as investors will also prefer to stay neutral ahead of the FOMC meeting this week.

SGD/MYR opened 0.01% higher at 3.4517, rallied to as high as 3.4550 before retreating to 3.4531 at the point of writing. Daily outlook is neutral-to-slightly bullish given its slightly oversold position, facing R1 and R2 at 3.4589 and 3.4621 respectively.

GBP/MYR Neutral-to-Slightly Bullish



Daily outlook is neutral-to-slightly bullish given the higher opening and upper trajectory subsequent to that, but gains likely capped for the rest of the day on growing angsts that the BOE may start cutting rates this week.

AUD/MYR Neutral-to-Slightly Bearish

AUD/MYR opened 0.01% higher at 3.0370 but quickly retreated to 3.0347 at the point of writing. Daily outlook is neutral-to-slightly bearish as the AUD/USD saw a further decline to 0.6538 at the point of writing. However, we expect further losses to be capped given its oversold position as well as cautiousness ahead of the Aussie price prints tomorrow, where expectations are that it will ease slightly to 3.8% y/y in 2Q from 4.0% y/y previously.
