Intraday Thoughts – Neutral-to-Slightly Bullish

USD/MYR opened 0.05% higher at 4.0417 and climbed further to 4.0450 at the point of writing. Daily outlook is neutral-to-slightly bullish with the escalation of tensions in the Middle East overnight that is keeping oil prices bid. There are no economic data releases due domestically for the day, with BNM set to decide on policy tomorrow. Over on the US side of things, overnight economic data saw the ISM manufacturing index for August and JOLTS job openings for July both fall short of expectations, while construction spending for July unexpectedly contracted and tonight will see the release of the ADP employment change for August and factory orders for July, with the Fed also set to release its latest Beige Book.

1-Month Outlook – USD/MYR Neutral

We are neutral on this pair on expectations that investors will stay cautious with the current geopolitical space still fluid, and on the fundamental front, supported by expectations that the FOMC will maintain rates at this level in the near term with the labour market softening, and inflation risk easing, the latter in line with the broadly softer crude oil prices as compared to the beginning of the war in March. On the domestic front, there is also no change in our view that BNM will maintain the OPR at 2.75% in the foreseeable future, given BNM's firm expectations for continued resilient growth for 2026 and benign price outlook, and as the central bank maintained a neutral stance in its latest policy statement, albeit with some positive twists such as resilient global growth to stronger than expected exports performance for Malaysia. In our opinion, this should certainly eliminate expectations for rate cut but not enough to signal a near term rate hike in our view, keeping Ringgit well supported in the near term.

GBP/MYR opened 0.15% lower at 5.4609 but recovered some of its losses to trade at 5.4627 at the point of writing. Daily outlook for the cross is neutral-to-slightly bearish, with mortgage approvals for July unexpectedly contracting overnight, and there is nothing on the economic calendar for the day in either country.

AUD/MYR opened 0.09% higher at 2.8879 before inching up further to trade at 2.8884 at the point of writing. We are neutral-to-slightly bullish on the cross for the day after Australian 2Q GDP beat expectations this morning, which will likely keep the AUD bid relatively.
