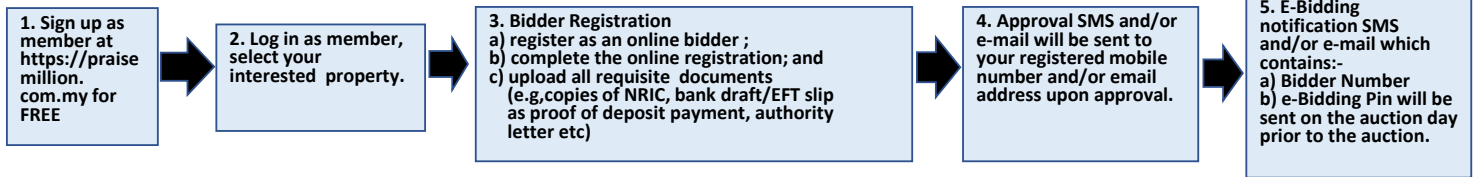

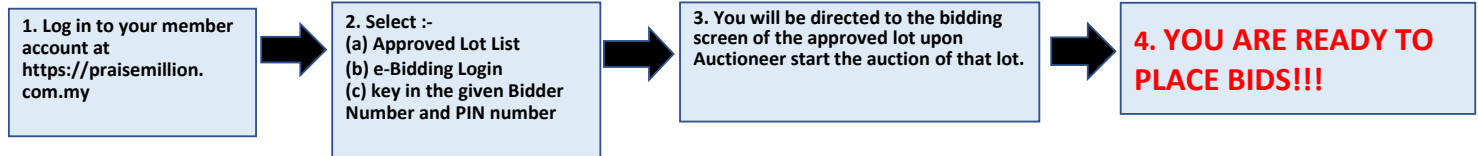


## HOW TO REGISTER AND BID ONLINE?
