

STEP 1 LOGIN TO www.leongauctioneer.com



STEP 2 SIGN UP FOR 1ST TIME USER **CHECK YOUR EMAIL AT INBOX OR** SPAM AND CLICK LINK TO ACTIVATE



STEP 3 **SELECT PROPERTY AND** REGISTER ONLINE



STEP 4 **BIDDERS SHALL PAY A 10% DEPOSIT** AT LEAST ONE (1) WORKING DAY **BEFORE AUCTION DATE**



STEP 5 ON AUCTION DAY LOGIN TO www.leongauctioneer.com AND BID ONLINE

HOW TO BID ONLINE:

I. On Auction day, click Secured Hyperlink (URL) in your email to enter our Auction Room at least 10 minutes before auction time.

- II. Click Auction date and Confirm Property Address and Reserve Price
