CAMPAIGN PERIOD

The Hong Leong Bank Berhad's (Company No. 193401000023 (97141-X)) ("HLB") "HLB Priority Wealth Odyssey Campaign - The Grand Selection for Curated Wealth Journeys ("Campaign") commences on **30 March 2026** and ends on **30 June 2026**, both dates inclusive ("Campaign Period"), unless notified otherwise.

TERMS & CONDITIONS

The terms and conditions applicable to the Campaign ("T&Cs") are as follows:

ELIGIBILITY

1. The **Campaign** is only open for participation to HLB Private Bank & HLB Priority customers, including Malaysian and Non-Malaysian individuals.
2. For the purpose of this **Campaign**:
 - a) "**HLB Priority Customers**" refers to existing individual customers with a total combined Asset Under Management ("**AUM**") and/or investment of **Ringgit Malaysia Five Hundred Thousand (RM500,000)**.
 - b) "**HLB Private Bank Customers**" refers to existing individual customers with a total combined Asset Under Management ("**AUM**") and/or investment of **Ringgit Malaysia Three Million (RM3,000,000)**.
 - c) "**AUM**" refers to total deposit in any Fixed Deposit Account ("**FD**"), Islamic Fixed Deposit Account ("**FD-i**"), Savings Account ("**SA**"), Islamic Savings Account ("**SA-i**"), Current Account ("**CA**"), Islamic Current Account ("**CA-i**"), Foreign Currency Account ("**FCA**"), Foreign Currency Fixed Deposit Account ("**FCY FD**") and/or the amount of investment in any Unit Trust Funds and/or Structured Products with HLB at any one time ("**Account**") under the primary accountholder's name.

Qualifying Criteria:

5. For joint accounts, only the principal/primary accountholder is eligible to participate in this **Campaign**. Secondary joint accountholders are not eligible to participate independently using the same joint account assets.

7. For existing FCA and FCY FD account balances prior to this campaign, the calculation of entries will be based on HLB's prevailing FCY exchange rate to Malaysian Ringgit ("MYR") at the end of the Campaign Period. The determination of the exchange rate by HLB under Clauses 7 and 8 shall be final and conclusive for this Campaign.
8. For Foreign Currency Investment and conversion amount transacted during the Campaign Period, the calculation of converted amount shall be based on HLB's prevailing FCY currency rate at the time of transaction in MYR.
