

**HONG LEONG DEBIT CARD “1-FOR-1 SATURDAY” PROMOTION**
*Last updated on 18 May 2017*
**PROMOTION PERIOD**

The Hong Leong Bank Berhad’s (97141-X) (“Bank”) **“Hong Leong Debit Card 1-for-1 Saturday Promotion”** (“Promotion”) commences on **13 May 2017** and ends on **29 July 2017**, both dates inclusive (“Promotion Period”), unless notified otherwise.

**Terms & Conditions**

The following sets-out the terms and conditions applicable to the Promotion (“T&Cs”):-

**ELIGIBILITY**

1. This Promotion is open to all Hong Leong Debit Cardholders with the Bank’s Debit Cards including Mach Debit Card issued by the Bank (“Debit Cards”).
2. This Promotion is **NOT** applicable to Hong Leong Islamic Debit Card-i.

**PROMOTION MECHANICS**

3. Debit Cardholders (“Cardholders”) who fulfill the following prescribed criteria by using their Debit Cards at the selected merchants as set-out in the table below (“Participating Merchants”) will be eligible to enjoy the following corresponding Promotion during the Promotion Period, subject to the terms & conditions stipulated by the Participating Merchants.

4. The Promotions are available on a first-come, first-serve basis and subject to stock availability, limited to **One (1) redemption per Debit Card every Saturday** during the Promotion Period at the respective Participating Merchants.
5. The Promotions are not exchangeable for cash nor can it be used in conjunction with other promotional programs, promotions, discounts, vouchers or privilege cards available in the respective merchants unless stated otherwise.
6. Popular Bookstores' Gift Voucher available in the Promotion is subject to additional terms and conditions indicated on the Gift Voucher and other terms and conditions of the Popular Bookstores of such Gift Voucher.
7. The GSC Promotion is only applicable for purchases of movie tickets on Saturday ("Selected Day") made via GSC website at [www.gsc.com.my](http://www.gsc.com.my) or GSC Mobile App during the Promotion Period and not for purchases made by any other methods including telephone and over the counter.
8. Cardholders can purchase multiple movie tickets to enjoy the GSC Promotion throughout the Promotion Period provided that:-
  - (a) each Debit Card will only be entitled to a maximum of one (1) GSC Promotion on Saturday; and
  - (b) advance movie ticket purchases are not eligible for this Promotion, i.e. tickets purchased must be for the movie screening on the same day as the transaction
9. The GSC Promotion is only applicable for normal adult 2D movie tickets sold at all GSC cinemas in Malaysia (excluding 3D movies, Dolby Atmos, Gold Class, Premiere Class, GSC Signature, Twin Seats, DBOX, Premium Leather Seat, and GSC Maxx).

10. For the avoidance of doubt, the GSC Promotion will be allocated on a first-come, first-serve basis with a daily capping of 420 GSC Promotion to be sold on each Selected Day throughout the Promotion Period (“Capped GSC Promotion”). Notwithstanding anything herein, no further GSC Promotion will be made available once the Capped GSC Promotions are fully sold.
11. The Participating Merchants may have its own terms and conditions applicable to the sale, supply and/or provision of the Promotions.
12. The Bank accepts no liability in respect of any additional promotions/discounts which the Participating Merchants may or may not promotion or any changes to the terms and conditions of the Participating Merchants.
13. The Participating Merchants reserves the right to change relevant details at any time without prior notice. Cardholders are advised to check the details and related terms and conditions with the staff of the Participating Merchants.

### **GENERAL**

14. By participating in the Promotion, the Cardholders:
  - (a) read, understood and agree to be bound by the T&Cs herein;
  - (b) agree to access the Bank’s Website at [www.hlb.com.my](http://www.hlb.com.my) (“HLB’s Website”) at regular time intervals to view the T&Cs and to ensure the Cardholders are kept up-to-date on any changes or variations to the T&Cs;
  - (c) agree that the Promotions are not exchangeable for up-front cash, credit, cheque or benefit-in-kind; and
  - (d) agree that the Bank and Participating Merchants’ decision on all matters relating to the Promotion shall be final, conclusive and binding on all Cardholders and no further correspondence and/ or appeal to dispute the Bank’s decision shall be entertained.

20. In the event of any discrepancy between the T&Cs as compared to any advertising, promotional, publicity and other materials relating to or in connection with the Promotion, the final T&Cs on the Bank's Website shall prevail.
