

HONG LEONG LI CHUN CONTEST

The Hong Leong Bank Berhad's (193401000023 (97141-X)) ("HLB") "Hong Leong Li Chun Contest" ("Contest") commences on 3 February 2021 and ends on 5 February 2021, both dates inclusive ("Contest Period"), unless otherwise notified by way of posting on HLB's website at www.hlb.com.my ("HLB's Website").

TERMS AND CONDITIONS

The following sets out the terms and conditions applicable to the Contest ("T&Cs"):

- 1. The **Contest** is open for participation by all individual HLB existing customers who are Malaysian and non-Malaysian residents ("**Participants**") unless notified otherwise.
- 2. Non-individual customers shall not be eligible to participate in the Contest, including Corporations, Business Entities, Solicitor Account Holders, Associations, Clubs, Schools, Societies, Non-profitable Organizations, Sole Proprietorships, Partnerships, Limited Liability Partnerships and Professional Practices duly registered or incorporated in Malaysia.

CONTEST MECHANICS
