



# Hong Leong Connect – Enjoy Zero Cost Instant Transfer for Credit Card/-i and Loan/Financing Payment

## **PROMOTION PERIOD**

"Hong Leong Connect Digital Banking Services ("HL Connect") – Enjoy Zero Cost Instant Transfer for Credit Card/-i and Loan/Financing Payment with HL Connect ("Promotion") by Hong Leong Bank Berhad (97141-X) ("HLB") and Hong Leong Islamic Bank Berhad's (686191-W) ("HLISB") [collectively and hereinafter referred to as "the Bank"], commences from 1 October 2017 to 31 December 2017, both dates are inclusive unless otherwise notified ("Promotion Period").

#### **TERMS AND CONDITIONS**

HL Connect User who satisfy the criteria as stated in Clause 3 herein will be referred to as the "Eligible Instant Transfer Customers".

- 4. For the purpose of this Zero Cost Instant Transfer Promotion for Credit Card/-i and Loan/Financing Payment, there is no maximum Fee Waiver capping for payment transactions throughout the Promotion Period.

Eligible Instant Transfer Customers can perform multiple fund transfers via Instant Transfer subject to the respective Eligible Instant Transfer Customer's total interbank fund transfer daily limit via Instant Transfer throughout the Promotion Period via HL Connect (Internet Banking & App) and be rewarded with the Fee Waiver.
- 6. The Bank shall not be responsible for and does not have any control or whatsoever on the traffic congestion, network or internet connection failure and/or interruptions that may be experienced, caused by the respective telecommunications service provider ("**Telco**") resulting in the delay of fund transfer via Instant Transfer during the Promotion Period.

#### **General T&C**

7. By participating in this Promotion, the HL Connect Users agree:





- (a) That they have read, understood and agreed to be bound by this T&Cs, the Terms and Conditions of HL Connect (Internet Banking & App) and any other relevant terms and conditions that the Bank may impose from time to time;
