

Personal Loan/Financing-i: HLB Mini Loan/HLISB Mini Financing-i

CAMPAIGN PERIOD

1. The Hong Leong Bank Berhad (“**HLB**”)’s and Hong Leong Islamic Bank Berhad (“**HLISB**”)’s (both HLB and HLISB are collectively referred to as “**the Bank**”) “HLB Mini Loan/HLISB Mini Financing-i” Campaign (“**Campaign**”) commences on 1 August 2019 and ends on 31 December 2019, both dates inclusive (“**Campaign Period**”), unless notified otherwise.

TERMS & CONDITIONS (“T&Cs”)

The following sets out the terms and conditions applicable to the Campaign:

ELIGIBILITY

2. The Campaign is open to all Malaysian individual primary credit cardholders of any financial institutions in Malaysia (“**Customers**”) who are within the following eligibility criteria:
 - (a) Aged between 21 to 60 years old;
 - (b) Employed with a minimum annual income of Ringgit Malaysia Twenty Four Thousand (RM24,000.00); and
 - (c) Do not have any existing HLB Personal Loan/HLISB Personal Financing-i with the Bank prior to this Campaign Period.
3. The following Customers are **NOT** eligible to participate in the Campaign:
 - (a) Customers who have committed or are suspected of committing any fraudulent, unlawful or wrongful acts in relation to any of the facilities granted by the Bank or have been declared bankrupt or are subject to any bankruptcy proceedings at any time prior to or during the Campaign Period;
 - (b) Customers who are determined by the Bank to be potentially committing any of the wrongful acts stipulated herein; and/or
 - (c) Permanent and contract employees of the Bank.

CAMPAIGN MECHANICS

4. In order to participate in this Campaign, Customers are required to:
 - (a) Apply for a HLB Personal Loan/HLISB Personal Financing-i with a minimum amount of Ringgit Malaysia One Thousand (RM1,000) and up to Ringgit Malaysia Twenty Five Thousand (RM25,000) (both HLB Personal Loan and HLISB Personal Financing-i are collectively referred as “**Facility**”) with available Facility tenures from 2 to 5 years (“**Facility Tenure**”) during the Campaign Period;

For the avoidance of doubt, Customers can only apply for the Facility via am:pm Terminals available at am:pm Convenient Banking Branches or Hong Leong InBranch Sales and Service Tablets available at selected Hong Leong Branches as per Appendix 1 attached herewith; and

- (b) Accept the Facility no later than 31 January 2020 and in order for the Facility to be disbursed no later than 31 January 2020.



For the purpose of this Campaign, Customers who have fulfilled all the criteria in Clause 4 above shall be referred to as “Eligible Customers”.

20 DAYS INTEREST/PROFIT-FREE OFFER

- 5. Eligible Customers are entitled to a 20 days interest/profit free offer (“Offer”) if they settle the full amount of the Facility within twenty (20) days after the disbursement date of the Facility (“Interest/Profit Free Period”). For the avoidance of doubt, Eligible Customers can only sign up for one (1) Facility during the Campaign Period and in the event that the Eligible Customers wish to sign up for another Facility, the Eligible Customers would need to fully settle the existing Facility prior to the acceptance of another Facility.

An example of the Interest/Profit Free Period is illustrated below:

Facility disbursement date: 5 August 2019

Last day of Interest/Profit Free Period: 25 August 2019 (20 days AFTER Facility disbursement date)

- 6. In the event the Eligible Customer settles the full amount of the Facility within the Interest/Profit Free Period, there will be no interest/profit charge on the Facility Amount.
- 7. In the event the Eligible Customer is unable to settle the full Facility Amount within the Interest/Profit Free Period for any reason whatsoever, the Eligible Customer shall serve the Facility in the manner as stipulated in the HLB Personal Loan/HLISB Financing-i Terms and Conditions and the following Flat Interest/Profit Rate and Facility Tenure for the Facility shall apply:

Product	Personal Loan/Financing-i
Facility Tenure	2 to 5 years
Facility Amount	RM1,000 – RM25,000
Flat Interest/Profit Rate	10.00% p.a. for any Facility Amount

Note: The effective interest/profit rates varies as follows for Facility Tenure from 2 to 5 years: Flat rate 10.00% p.a. - Effective interest/profit rate varies from 17.27% p.a. to 18.16% p.a.

- 8. This Offer is only applicable to the Facility. HLB Personal Loan Add-A-Loan/HLISB Personal Financing-i Add-A-Financing, HLB Personal Loan Consolidation/HLISB Personal Financing-i Consolidation are not applicable under this Offer.
- 9. A convenience fee of RM75.00 (“Convenience Fee”) will be deducted from the Facility Amount upon disbursement and is non-refundable regardless of whether the Eligible Customer has fully settled the Facility within the Interest/Profit Free Period.
- 10. On top of the Convenience Fee, a stamp duty of 0.50% of the Facility Amount is applicable and shall be deducted from the Facility amount upon disbursement.



11. In the event of early settlement of the Facility, i.e. after the Interest/Profit Free Period and before the expiry of the Facility Tenure (“**Early Settlement**”) for:

a) HLB Personal Loan

The Customer may at any time during the Facility Tenure, effect Early Settlement of the Facility in full by giving three (3) months’ prior written notice (“**Notice**”) to the Bank, or make payment of three (3) months’ interest/profit on the amount redeemed, in lieu of Notice. A rebate for Early Settlement (“**Rebate**”) on the remaining interest to be charged on the Facility will be granted to the Eligible Customer over the unexpired period of the Facility Tenure commencing after the Notice period and provided always that the Eligible Customers fully settles the outstanding amount of the Facility within the time period as may be stipulated by the Bank. The Rebate shall be calculated in accordance with the following formula**:

$$R = \frac{(n-3)(n-2)}{N(N+1)} \times I \text{ where,}$$

- R** Rebate (RM)
- n** Number of monthly instalments over the unexpired period of the Facility Tenure
- N** Facility Tenure (in months)
- I** Interest Payable for the whole Facility Tenure (RM) at the rate of 10.00% per annum

An illustration of how the Rebate is calculated for a sixty (60) months i.e. (5 years) Facility with a principal amount of RM5,000 and interest rate of 10.00% per annum, but with early settlement after twenty (20) months (where Notice is served on the Bank before the next monthly instalment due date), is provided below:

 N &= 60 \\
 n &= 60 - 20 = 40 \\
 I &= 5,000 \times 10.00\% \times 5 = \text{RM}2,500 \\
 R &= \frac{(40-3)(40-2)}{60(60+1)} \times \text{RM}2,500 = \text{RM}960.38
 \end{aligned}$$

Note:

**The Rebate will be calculated based on the "Rule of 78" or "Sum of Digits" whereby the method of calculation of the proportion of principal and interest payable for the entire Facility assumes that the interest forms a larger percentage of the monthly instalments during the early stage of the Facility. The Customer shall repay all monthly instalments payable over the unexpired period of the Facility Tenure subject to the Rebate.

b) HLISB Personal Financing-i

The Customer may at any time during the Facility Tenure, effect Early Settlement of the Facility in full by giving the Notice to the Bank. A rebate (ibra’) for Early Settlement on the remaining profit to be charged will be granted to the Eligible Customer over the unexpired period of the Facility Tenure commencing after the Notice period (“Rebate for

Personal Financing-i”). The Rebate for Personal Financing-i shall be calculated in accordance with the following formula**:

$$R = \frac{n(n + 1)}{N(N + 1)} \times P \text{ where,}$$

R Rebate (RM)
 n Remaining number of instalment
 N Facility Tenure (in months)
 P Profit Payable for the whole Facility Tenure (RM) at the rate of 10.00% per annum

An illustration of how the Rebate For Personal Financing-i is calculated for sixty (60) months financing (5 years) with a principal amount of RM5,000 and profit rate 10.00% per annum, but with Early Settlement after twenty (20) months (whereby the Notice is served on the Bank before the next monthly instalment due date), is provided below:

 N &= 60 \\
 n &= 60 - 20 = 40 \\
 P &= 5,000 \times 10.00\% \times 5 = \text{RM}2,500 \\
 R &= \frac{(40-3)(40-2)}{60(60+1)} \times \text{RM}2,500 = \text{RM}960.38
 \end{aligned}$$

Note:

**The Rebate for Personal Financing-i will be calculated based on the “Rule of 78” or “Sum of Digits” whereby the method of calculation of the proportion of principal and profit payable for the entire Facility assumes that the profit forms a larger percentage of the monthly instalments during the early stage of the financing. The Eligible Customer shall pay all the monthly instalments payable over the unexpired period of the Facility Tenure subject to the Rebate for Personal Financing-i.

GENERAL

12. By participating in the Campaign, the Customers hereby:

- i. agree that they have read, understood and agreed to be bound by the T&Cs herein and the [HLB Personal Loan Terms and Conditions and HLISB Personal Financing-i Terms and Conditions](#);
- ii. agree that they have read, understood and agreed to be bound by the [Bank’s Privacy Notice](#);
- iii. agree to access the Bank’s Website at www.hlb.com.my and/or www.hlisb.com.my (collectively, “the Bank’s Website”) at regular time intervals to view the T&Cs and to ensure to keep-up-to-date on any changes or variations to the T&Cs;
- iv. agree to furnish all the relevant documents as may be requested by the Bank in a timely manner in order for the Facility to be approved and disbursed by 31 January 2020 and the Bank shall not be responsible in the event that the Facility cannot be disbursed by 31 January 2020 for any reasons whatsoever;
- v. agree that the decision by the Bank on all matters relating to the Campaign shall be final, conclusive and binding and no further correspondence and/or appeal to dispute such decisions will be entertained; and



agree that they shall be liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in the Campaign.

13. The Bank reserves the right to:

- i. reject at its sole and absolute discretion any Facility application submitted without assigning any reason thereof;
- ii. disqualify any Customer at its sole and absolute discretion from participating in the Campaign; and
- iii. add, delete, suspend or vary the T&Cs contained herein, wholly or in part, or terminate the Campaign at its absolute discretion, by way of posting on the Bank's Website or in any other manner which the Bank deems practical.

14. The T&Cs herein and the terms and conditions governing the HLB Personal Loan/HLISB Personal Financing-i shall be read together as an entire agreement. In the event of any discrepancies between the T&Cs of this Campaign and the terms and conditions governing the HLB Personal Loan/HLISB Personal Financing-i the specific T&Cs herein shall prevail to the extent of such discrepancies.

15. In the event of any discrepancies between the T&Cs herein as compared to the advertising, promotional, publicity and other materials relating to or in connection with the Campaign, the final terms and conditions on the Bank's Website shall prevail.

16. The T&Cs herein shall be governed by and construed in accordance with the laws of Malaysia and the Customers agree to submit to the exclusive jurisdiction of the Courts of Malaysia.

17. Words denoting one gender include all other genders and words denoting the singular include the plural and vice versa.
