

"Revenue Harvest (Malaysia e-Banking) 2017 Mid-Year Sales Post & Win Contest"

TERMS & CONDITIONS

By participating in this Contest, the participants hereby expressly agreed to be bound by the terms and conditions of this Contest ("Terms & Conditions") and the decisions made by Revenue.

"Internet Banking Payment Transaction" refers to desktop/mobile point of sales service which allows the Connect user defined below to perform payment transactions through Hong Leong Connect Internet Banking on a desktop/ mobile for any purchase made at Taobao® Marketplace.

"PEx+ Payment Transaction" refers to mobile point of sales service which allows the Connect user defined below to conduct payment transaction through Hong Leong Connect Mobile and/or Connect Tablet application on a smart phone and/or tablet for any purchase made at Taobao® Marketplace.

ELIGIBILITY FOR THIS CONTEST

- 1) Subject to these Terms and Conditions, to participate in this Contest, the participants must:
 - a) have a valid personal Hong Leong Bank account who are the registered users of Connect and subscribed for Hong Leong Connect Mobile/Tablet application ("Connect users"); and
 - b) place an order on Taobao® Marketplace (http://world.taobao.com) (including its regional websites) or the Tmall Global Platform (http://www.tmall.com) and successfully check out the Internet Banking Payment Transaction or PEx+ Payment Transaction during the Contest Period ("Eligible Transaction"). ("Eligible Participants")
- 2) The following transactions are **NOT** eligible to participate the Contest:-
 - a) transactions which are subsequently cancelled or refunded(whether full or partial cancellation or refund
 of purchase orders) including but not limited to transactions cancelled by Hong Leong Bank for any
