Campaign Period

- (e) both HLB Personal Loan and HLISB Personal Financing-i are collectively known as "Facility";
- (f) submit the application for the Facility through Hong Leong Connect Online Banking; and
- (g) disbursement of the approved Facility by the Bank no later than 31 July 2019.
- 2. For the purpose of this Campaign, Customers who have fulfilled all the criteria in Clause 1 above shall be referred to as "Eligible Customers".
- 3. The following are **NOT** eligible to participate in the Campaign:
