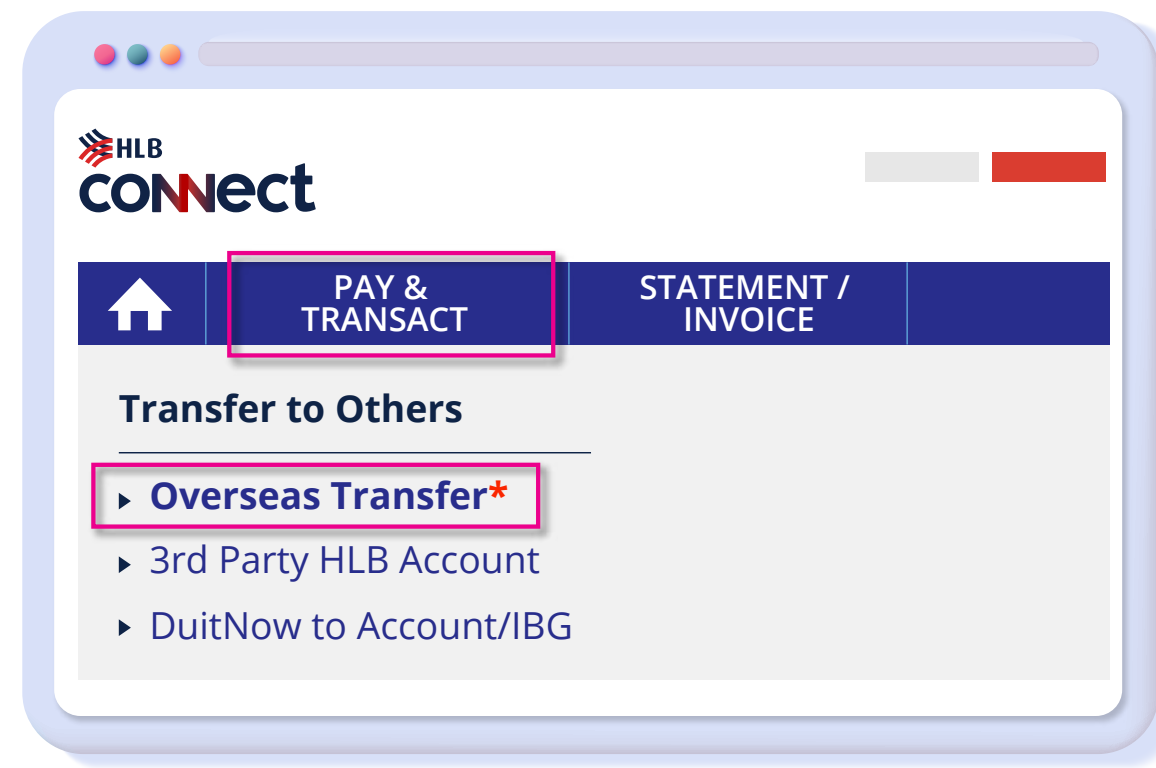




Send to Vietnam (cash pickup)
