HLB Designed by You ("DBY") is an online community platform created specifically for Hong Leong Connect Users ("Connect Users"). DBY focuses on idea generation and feedback gathering among the Hong Leong Connect community. Connect Users who have followed the instructions as provided in Clause 3(i) below and become DBY Users (herein refer as "DBY Users") can express or contribute valuable ideas or feedback to Us as a banking customer in general.

In DBY, We actively work towards:

- Collaboration in ideation to create better banking services for everyone;
- Active participation of DBY Users in DBY;
- Creating a safe community within DBY;
- Cultivating a network of support and encouragement for each other; and
- Encouraging responsible and varied forms of expression.

These terms and conditions shall govern Your use of DBY. By accessing and using DBY, You are deemed to have agreed to be bound by these T&Cs and any amendments made there to without limitation or qualification. As such, please read and understand these T&Cs carefully. Should You not accept or





agree to these T&Cs, You are required to discontinue Your access to DBY and utilization of the services provided via DBY.

2. Definitions and Interpretation

HLB Designed by You ("DBY")	Means the online community platform where Connect Users share their ideas or opinions, hosted by the Bank.
DBY User(s), You, Your	Connect Users who have registered to become a member of DBY.
We, Our or Us	Means DBY administration team.
Hong Leong Connect	Means HLB Connect Online and HLB Connect App, where Connect Users can perform online banking transactions.
Privacy Notice	Means the Bank's policies and principles pertaining to the collection, use and storage of personal information of existing and prospective individuals and entities (including but not limited to DBY Users) dealing with the Bank as may be amended from time to time and made available at <u>www.hlb.com.my</u> or in such manner as the Bank deems appropriate from time to time.
Post(s), posting(s)	An idea / comment / statement posted by DBY Users in DBY, including a response to an idea posted by DBY User to another DBY User, whether in text, graphic form, video, audio, computer software or any other form.





3. Eligibility

All Connect Users are allowed to participate in DBY.

- i. To access DBY, the Connect Users must have a HLB Connect Online account and Connect Users will have to login to HLB Connect Online and click on the 'Designed by You' icon where Connect Users will be guided in becoming a DBY User and set up a DBY account.
- ii. DBY Users may be required to provide the Bank/Us with certain information as may, in the Bank's / Our sole opinion, be required in order to generate a DBY account for the DBY Users which may include, inter alia, name, identification/passport no., identification type, date of birth, gender and contact numbers, wherever applicable. After completion of the requisite steps, DBY User's access to DBY will, subject to the terms herein, be activated.

4. Rules of DBY

DBY Users agree and acknowledge that:

- i. DBY Users are responsible for all content of the Post(s), messages and online activities conducted through his/her DBY account;

- xi. You will not impersonate any person or entity or to falsely state or otherwise misrepresentYour affiliation with any person or entity;
- xii. You will not send, distribute or upload, in any way, data or materials that contain viruses, malicious code or harmful components that may impair or damage the operation of another's computer or equipment;
- xiii. You will, if asked by Us, cease posting and/or delete any Posts or contents that deemed improper by Us.

7. Disclosure of Information

- iv. You are responsible in protecting and safeguarding Your own personal information. You should not reveal or disclose any personal information, e.g. account number, password, PIN, e-mail, contact number or any personal identifiable information in DBY under any





circumstances. The Bank or We will never ask from You for such information in safeguarding the confidentiality of Your personal information.

10. Termination

- i. We are entitled to terminate, suspend, and/or restrict Your use DBY at Our sole and absolute discretion, should any one (1) or more of the following occur:
 - a. You cease to be a DBY User; or

 - You have become, threaten, or resolve to become or is in jeopardy of becoming subject to any form of insolvency administration or bankruptcy proceedings (where applicable).
- ii. Notwithstanding anything herein to the contrary, We may at any time, in our sole and absolute discretion terminate, suspend, and/or restrict Your right of access to DBY or any portion of it without notice and without any obligation to give any reasons therefore or for any reason whatsoever.
- iii. For the avoidance of doubt, You acknowledge that terminations shall not affect Your liability or obligations in respect of any instructions on DBY processed by Us on Your behalf.
- iv. You agree and acknowledge that You shall not hold the Bank or Us liable for any loss, whichYou may suffer as a result of termination of the use of DBY.

12. Rewards

- iii. Compensation Distribution
