

TERMS AND CONDITIONS

Organiser & Qualifications

1. **“Spend & Win – MyDebit Je With Your ATM Card!”** [“Contest”] is jointly organised by Billion Shopping Center (Semenyih) Sdn Bhd (Company No.: 200401018071 (656574-X) (Billion) and Payments Network Malaysia Sdn Bhd (Company No: 2000801035403 (836743-D)) (PayNet) [“The Organiser”].

2. The Contest is open to all MyDebit Automated Teller Machine [“ATM”] card holders issued by participating financial institutions authorizing MyDebit services in Malaysia. The mentioned card holders must be a permanent resident in Malaysia or a Malaysian citizen who is 18 years of age and above and has a valid identification card during the Contest Period [“Participant”]. The Participant must also have a valid account with any of the abovementioned financial institution in Malaysia and the account must be active with a good financial standing and not dormant during the entire Contest Period until the completion of the redemption of prizes.

3. Individuals listed below are not eligible to participate in this Contest:
 - Employees of the Organiser [including its associates, subsidiaries or related thereto] and their immediate family members [children, parents, siblings, including spouses]; and/or
 - Representatives, employees and/or the advertising agencies or promotional agencies of the Organiser [including its associated and related companies], and their immediate family members [children, parents, siblings, spouses].

3. Only payment/transaction made using MyDebit ATM card will be accepted for this Contest. Entries received beyond Contest Period will be deemed invalid and will be forfeited.

4. The Organiser reserves the right to amend, extend or terminate the Contest at its sole and absolute discretion with prior notice.
5. A minimum purchase of RM80 and above at any Billion & Pantai Timor stores using MyDebit ATM card as a mode of payment made within the Contest Period (with a clear printed transaction receipt along with bank slip printed from terminal)) may be entitled to be regarded as a valid entry [**“Proof of Purchase”**]. Participant who is selected as winner [**“Winner”**] is required to submit their Proof of Purchase (original) before the redemption/fulfillment of the prizes can be completed. Failure to do so would result in the cancellation of the prizes won by the Winner.

How to Participate (1): via WhatsApp

- o **Each complete entry must** contain the following information:

 - iii. Participant will receive a reply message (Contest questions, privacy notice) via the WhatsApp app within 48 hours (on weekdays); and
 - iv. Participant should reply to the message by agreeing to the privacy notice and answer questions correctly to **016 357 9878**.

How to Participate (2): via Whoop app (downloadable via Play Store for Android / App Store for iOS)

- i. Sign up for Whoop! App (registration for the first time only);
- ii. Click on the **“Spend & Win – MyDebit Je With Your ATM Card!”** banner;
- iii. Take a photo of the Proof of Purchase and keep the Proof of Purchase;
- iv. Correctly answer the Contest questions and complete the required information;
- v. Participant will receive an immediate acknowledgement upon submission; and
- vi. By submitting entries via Whoop! app, the Participant is deemed to have read and agreed to the privacy notice set forth in the Terms and Conditions herein.

Note: Every valid purchase worth RM80 and above (in a single transaction slip) will be automatically assigned with **ONE (1)** random serial number (in the database system). (Note: each accumulated value of RM80 = 1 serial number (1 entry), RM160 = 2 serial number (2 entries), RM240 and above = maximum 3 serial number (3 entries). The serial number is for the Organizer reference only. It will not be disclosed to the Participant.

2. Each Proof of Purchase can only be used once. The Participant entries will be **disqualified** in the event where the Proof of Purchase is used for more than ONE (1) time.
3. Each Participant is only eligible to win ONE (1) prize during the Contest Period.
