## TERMS AND CONDITIONS

## Organiser & Qualifications

- "BELANJA DAN MENANG DENGAN KAD ATM MYDEBIT" ["Contest"] is jointly organised by Watsons Personal Care Stores Sdn Bhd (Company No.: 199401004213 (289892 V)) and Payments Network Malaysia Sdn Bhd (Company No: 2000801035403 (836743-D)) (PayNet) ["The Organiser"].
