



# 2022 HLB DEEPAVALI "SOUND OF DEEPAVALI" FB & IG KOLAM CONTEST TERMS AND CONDITIONS

The 2022 HLB Deepavali "Sounds of Deepavali" FB & IG Kolam Contest ("Contest") is a social media contest organized by Hong Leong Bank Berhad (193401000023 (97141-X)) ("Bank" or "HLB") which commences on 11 October 2022 and ends on 24 October 2022, both dates inclusive ("Contest Period"), unless otherwise notified.

#### **Terms and Conditions**

1) The following sets out the terms and conditions applicable to the Contest ("T&Cs"):-

## **Eligibility**

- 2) This Contest is open to all Malaysian individuals irrespective of whether they are customers of the Bank or otherwise ("Participants").
- 3) In order to be eligible for this Contest, all requirements must be fulfilled in accordance with the Contest Mechanics below.
- 4) The following persons are **NOT** eligible to participate in the Contest:
  - Permanent and contract employees of HLB and Hong Leong Islamic Bank (including its subsidiaries and related companies) and their respective immediate family members (e.g. spouse, children, parent, brother or sister).

#### **Contest Mechanics**

To become a fan of the HLB's Facebook Page and HLB's Instagram Page, the Participants have to click "Like" on HLB's Facebook Page and "Follow" on HLB's Instagram Page. No registration with HLB is required for this process.

## **How to Participate**

- Visit HLB Deepavali Personalized Kolam Generator Website at <a href="https://www.hlb.com.my/Deepavali">https://www.hlb.com.my/Deepavali</a>
- 6) Participants are required to generate their personalized kolam by pressing 'Press Record' to record 10 seconds of any sounds to generate the personalized kolam. After the kolam is generated, participants can customize the colors and greeting message. Thereafter, participants need to





'Share' the personalized kolam generated to their own FB profile or IG feed, tag Hong Leong Bank's official FB page @HLBMalaysia or Hong Leong Bank's official IG page @hongleongbankmy, hashtag #SoundsOfDeepavali, and tag 3 friends ("Eligible Contest Entries"). Uploaded FB or IG post must have visibility set to "Public". Participants are allowed to submit more than one (1) contest entry throughout the Contest Period to increase their chances of success.

7) HLB reserves the right to disqualify and/or delete any contest entry containing nudity, vulgarity, obscenity, racist sentiments, profanity, violence, or any other elements deemed inappropriate by HLB (including but not limited to infringement of any third-party intellectual property rights). HLB shall not be responsible for any such contest entry disqualified and/or deleted or in the event, any contest entry is unsuccessfully posted due to technical or internet connection issues or for any other reason whatsoever.

## **Prize Selection and Fulfilment**

- 8) The contest prize consists of RM100 worth of Shell e-vouchers (RM20 x 5 e-vouchers) ("Contest Prize"). There are a total of 50 (Fifty) Contest Prizes to be given out in this Contest.
- 9) Shell e-vouchers Terms and Conditions apply. The e-voucher is valid until 2 Jan 2023, 23:59:59 +0800.
- 10) Each Participant is entitled to win only one (1) Contest Prize in this Contest.
- 11) The Eligible Contest Entries will be selected by HLB randomly. The Participants of the selected Eligible Contest Entries who have fulfilled the requirements in Clause 4 to Clauses 6 (as applicable) above shall be eligible to be selected as a winner ("Winners").
- 12) The Winners will be notified **by 6 November 2022** via the Winners announcement post on the Bank's official Facebook and/or Instagram page.

- 15) If the Winners fail to email HLB all the required details within the timeframe as specified in Clause 13 above, the Winners will be disqualified from the Contest and shall not be entitled to the Contest Prizes.
- 16) The Contest Prize will be emailed to the Winners by 18 November 2022.





- 17) For the avoidance of doubt, HLB reserves the right to determine the Winners and any dispute(s) pertaining to HLB's decision shall not be entertained. The Contest Prizes are non-exchangeable by cash or in kind.
- 18) It is the obligation of the Winners to inform HLB in writing in the event of non-receipt of the Contest Prizes by 25 November 2022, failing which the Winners are deemed to have received the Contest Prizes and any appeal/request for the reimbursement of the Contest Prizes thereafter shall not be entertained.
- 19) HLB reserves the right to replace the Contest Prizes with any other item of equal value at its discretion.

#### **General**

- 21) By participating in the Contest, the Participants agree:
  - a) to have read, understood, accepted and agree to be bound by the T&Cs herein;
  - that HLB's decision on all matters relating to the Contest shall be final, conclusive and binding on all Participants and no further correspondence and/or appeal to dispute HLB's decision shall be entertained;
  - to authorise and consent to the Bank's usage, disclosure or publication of their IG Handle and Contest Entries at no cost for publicity, advertising, trade or promotion purposes in any media;
  - d) to access the HLB's contest website at https://www.hlb.com.my/Deepavali ("Contest Website") at regular intervals to view the T&Cs of the Contest and ensure to be kept up-to-date on any changes or variations to the T&Cs; and
  - e) to be liable and shall personally bear all applicable taxes, government fees, or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in the Contest.
