

HONG LEONG BANK BRANCH DOUBLE ABUNDANCE CNY UTFD BUNDLE

ELIGIBILITY PERIOD

The Hong Leong Bank Berhad's (193401000023 (97141-X)) ("HLB") "Hong Leong Bank Branch Double Abundance CNY UTFD Campaign" ("Campaign") commences on 6 January 2023 and ends on 28 February 2023, both dates inclusive of ("Campaign Period"), unless otherwise notified by way of posting on HLB's website at www.hlb.com.my ("HLB's Website").

TERMS AND CONDITIONS

The following sets out the terms and conditions applicable to the Campaign ("T&Cs"):

ELIGIBILITY

- 1. This Campaign is open to HLB's Existing and New customers, both Malaysian and non-Malaysian citizens ("**Customers**").
- 2. For the avoidance of doubt:
 - a) New Customers refer to individual primary accountholders who do not have any Accounts or Investments with HLB prior to the Campaign Period and have opened a Fixed Deposit Account and an Investment Account for this Campaign during the Campaign Period.
 - b) Existing accountholders refer to individual primary accountholders who have opened a Current/Savings Account or Fixed Deposit Account or Investment Account prior to the Campaign Period.
- 3. This Campaign enables the Customers to obtain Promotional FD Rates for the Participating FD Accounts, subject to the Campaign Mechanics below being fulfilled.

CAMPAIGN MECHANICS

- This Campaign enables the Customers to obtain Promotional FD Rates, subject to the Campaign Mechanics below being fulfilled (as stated under clause 4). The participating Fixed Deposit ("FD") account ("Participating FD Account") for this Campaign is HLB's Conventional FD.
- Customers are required to invest a sum of minimum RM20,000 in any of the selected Unit Trust Fund ("UT") (refer Appendix 1), subject to minimum UT sales charge ("Eligible Customers") to be eligible for the 1-month FD at 9.88% p.a. or 3-month FD at 7.18% p.a. ("Promotional FD Rates").
- 5. The maximum FD placement amount for the Promotional FD Rates is capped at 0.5x of UT investment amount.

Should there be an Overnight Policy Rate (OPR) change, HLB reserves the right to revise the promotional FD rates.

6. For the avoidance of doubt, Table 2 illustrates the UTFD ratio based on the criteria provided in Table 1 above.

- 7. Based on Table 2, the UT Investment Amount for the Eligible Customer is Ringgit Malaysia Twenty Thousand (RM20,000). The Customer will be eligible up to a Ringgit Malaysia Ten Thousand (RM10,000) FD placement in any of the Promotional FD Rates shown in Table 2 above.
- 8. The UT order date shall be considered as the UT investment date for the selected UT products listed in Appendix 1.
- 9. The FD placement and UT investment have to be done concurrently on the same day during the Campaign Period.
- 10. The fund size limit for the Promotional FD Rates is capped at Ringgit Malaysia Fifty Million (RM50,000,000)("**Fund Size Limit**"), subject to first-come, first-served basis.
- 11. In the event any FD Placement amount exceeds the Maximum FD Placement Amount or if the Fund Size Limit is reached, then such FD Placement amount shall be subject to the prevailing FD board rates as determined by the Bank.
- 12. Promotional FD Rate is applicable for **New Funds** only.
- 13. **New Funds** are defined as cash, Financial Process Exchanges ("**FPX**"), instant transfer, interbank GIRO, new funds received via telegraphic transfer from other banks, local cheque or banker's cheque issued by other banks which are deposited into the Participating FD Accounts, HLB Current Account or Savings Account of the Customer.
- 14. The following shall **NOT** be considered as "New Funds":
 - a) maturing FD or premature withdrawal of FD from any existing FD Accounts with HLB;
 - b) intra bank transfer of funds, i.e., transfer of funds from another HLB/HLISB account (whether CASA, FD or General Investment Account; and
 - c) inter and/or intra branch transfer within HLB including by third party account transfer.
- 15. This Campaign is NOT valid with any other on-going promotions offered by HLB from time to time.
- 16. Each Eligible Customer is only entitled to one (1) Promotional FD Rate for UT Investment made during campaign period.



17. The Eligible Customers who do not have any CASA with HLB prior to the Campaign Period are required to open one and nominate a CASA maintained with the Bank under the same name and signature requirement as the Participating FD Account ("**Nominated CASA**") for the purpose of crediting the interest earned under this Campaign.

- 18. The interest earned for the Participating FD Accounts shall be credited into the Eligible Customers' Nominated CASA at maturity.
- 19. Upon maturity, the principal FD Placement amount shall be auto-renewed at the prevailing FD board rates respectively for the same amount of period and the interest earned will be credited into the Eligible Customers' Nominated CASA at maturity for each period.
- 20. No interest shall be payable on partially withdrawn amounts and premature withdrawals of the FD, regardless of the number of completed months at the time of premature withdrawal. For the avoidance of doubt, the interest/profit will be calculated on the remaining balance principal amount subsequent to the withdrawal.
- 21. Subject to Clause 20 above, partial withdrawal of the FD is allowed in multiples of Ringgit Malaysia One Thousand (RM1,000) only. Any withdrawal which causes the minimum balance of the Participating FD Account to fall below Ringgit Malaysia Ten Thousand (RM10,000) shall be treated as a premature withdrawal of the entire FD.
- 22. FD Placement Amount shall **NOT** be used as collateral for the purpose of securing any credit facility obtained or to be obtained by the Eligible Customers with the exception that the FD Placement Amount of the Conventional FD can be used as collateral to secure the eligible Credit Card(s) with HLB. Please refer to the Secured Credit Card with Fixed Deposit Terms & Conditions for more information.
- 23. The Primary Accountholder for both the Investments and the FD account must be under same name of the Eligible Customers.
- 24. In the event the Eligible Customers exercise their Unit Trust cooling-off right or any of the UT Investment is rejected or cancelled by any parties for whatsoever reason, Eligible Customers shall NOT be eligible to the Promotional FD Rate as stipulated in the tables illustrated. Accordingly, the funds placed deposited in a FD account will be uplifted and no interest shall be paid.

<u>GENERAL</u>

25. By participating in the Campaign, the Eligible Customers agree:



a) that they have read, understood and agreed to

be bound by the T&Cs herein; General Terms and

Conditions of Accounts, terms and conditions applicable to the participating FD and;

- b) that all records of the fulfilment of the eligibility requirement captured by HLB's system within the Campaign Period are final;
- c) that HLB's decision on all matters relating to the Campaign shall be final, conclusive and binding on the Eligible Customers;
- d) to access HLB's websites at (<u>www.hlb.com.my</u>) ("HLB's Website") at regular intervals to view the T&Cs of the Campaign and ensure to be kept up-to-date on any changes or variations to the T&Cs;
- e) that the interest earned is non-transferable to any third (3rd) party and nonexchangeable for up-front credit, cheque or benefit in-kind; and
- f) to be liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in the Campaign.
- 26. HLB reserves the right:
 - a) With prior notice to the Customers, to add, delete, suspend or vary any or all of the T&Cs contained herein either fully or partially or terminate the Campaign by way of posting on HLB's Website, or in any other manner;
 - b) To forfeit the interest earned in the event of non-compliance by the Eligible Customers of the T&Cs herein, General Terms and Conditions of Accounts, terms and conditions applicable to the Participating CASA and FD; and
 - c) To claw-back the interest paid in the event there is any detected fraud, breaches against the Campaign's T&Cs.
- 27. The T&Cs herein, General Terms and Conditions of Accounts, terms and conditions applicable to the Participating CASA, and FD shall be read as an entire agreement. In the event of any discrepancy between the T&Cs herein, General Terms and Conditions of Accounts, terms and conditions applicable to the Participating CASA and FD, the T&Cs herein shall prevail to the extent of such discrepancy.
- 28. In the event of any discrepancy between the T&Cs herein and any advertising, promotional, publicity and other materials relating to or in connection with the Campaign, the final T&Cs on HLB's Website shall prevail.
- 29. The T&Cs shall be governed by and construed in accordance with the laws of Malaysia and the Eligible Customers agree to submit to the exclusive jurisdiction of the Courts of Malaysia.
- 30. Words denoting one gender include all other genders and words denoting the singular include the plural and vice versa.
