

**HLB JURASSIC WORLD REBIRTH CREDIT CARD ACQUISITION PROMOTION (PRINCIPAL CREDIT CARD OFFER)**

Last updated as of 14 June 2025

**PROMOTION PERIOD**

The Hong Leong Bank Berhad's (193401000023 (97141-X)) ("HLB") "**HLB Jurassic World Rebirth Credit Card Acquisition Promotion (Principal Credit Card Offer)**" ("**Promotion**") commences on **14 June 2025** and ends on **18 June 2025**, both dates inclusive ("**Promotion Period**"), unless specified herein or notified otherwise.

**TERMS AND CONDITIONS**

The terms and conditions applicable to the Promotion ("**T&Cs**") are as follows:

**ELIGIBILITY**

1. The Promotion is open to individuals without an HLB credit card (New-to-Card Applicants) ("**NTC Applicants**") who have, during the Promotion Period, applied for at least one (1) of the HLB Credit Cards in **Table 1** below ("**Eligible Cards**") through any of the following channels ("**Eligible Channels**"):
  - (a) HLB Direct Sales (only applications submitted at IOI City Mall Putrajaya, IOI Puchong & GSC booths at Mid Valley & KL East Mall are eligible);
  - (b) HLB Connect Online; or
  - (c) HLB Corporate Website at [www.hlb.com.my](http://www.hlb.com.my) ("**HLB's Website**").

2. The following shall **NOT** be eligible to participate in the Promotion:
  - (a) existing principal or supplementary cardholders of any HLB Credit Cards;
  - (b) NTC Applicants who have joined other HLB Credit Card acquisition promotions during the Promotion Period unless stated otherwise;
  - (c) previous HLB principal cardholders who have cancelled their HLB Credit Cards and have reapplied for a new HLB Credit Card (including but not limited to any of the Eligible Cards) as a principal cardholder within twelve (12) months from the date of such cancellation;
  - (d) NTC Applicants who have committed or are suspected of committing any fraudulent, unlawful or wrongful acts in relation to any of the facilities granted by HLB and/or Hong Leong Islamic Bank (200501009144 (686191-W)) ("**HLISB**") or have been declared bankrupt (pursuant to a petition by either a bank or by any third party) or

- were/are subject to any bankruptcy proceedings at any time prior to, during or after the Promotion Period; and
- (e) existing staff of HLB and/or HLISB and/or Hong Leong Group.
3. For the purpose of the Promotion, all applications for the Eligible Cards by the eligible NTC Applicants via the Eligible Channels during the Promotion Period are subject to HLB's approval and all applications must be successfully approved by HLB by **20 June 2025** at the latest, and upon such approval, such applicants shall become eligible cardholders ("**Eligible Cardholders**"). For the avoidance of doubt, the Bank will conduct its own internal assessment to determine, in its discretion, decide whether to approve the NTC Applicants applications. Any decision by the Bank of the approval shall be subject to the Bank's prevailing credit policies, procedures and eligibility criteria, and the Bank shall have no obligation, whether express or implied, to approve the NTC Applicants applications.

### **PROMOTION MECHANICS**

4. Subject to the fulfilment of conditions as set out under **Clauses 1** and **3** above and the other terms and conditions stated herein, Eligible Cardholders can participate in the following offer(s), subject to the Approval Gift Allocation Cap (as defined under **Clause 4(b)(ii)** below):
- (a) **Criteria for Annual Fee Waiver Offer**
- (i) each Eligible Cardholder who performs a minimum of one (1) Eligible Spend (as defined under **Item (ii)** below) of any amount using the Eligible Card within sixty (60) days from the approval date of the Eligible Card ("Eligible Spend Duration") will be entitled to an annual fee waiver for the 1st year ("**Annual Fee Waiver**"). For the avoidance of doubt, each Eligible Cardholder may receive only one (1) Annual Fee Waiver per Eligible Card throughout the Promotion Period.
  - (ii) "**Eligible Spend**" refers to any retail and online purchases (including, without limitation, standing instructions and the full amount of purchase(s) under 0% Interest Easy Payment Plan) transacted locally and/or overseas (whether the spending is transacted in Ringgit Malaysia ("**RM**") and/or other currencies) which have been successfully charged to the Eligible Cards within the Eligible Spend Duration. Purchases made in currencies other than RM will be converted to and computed in RM based on the conversion rate determined by HLB at the time of the transaction.
  - (iii) Eligible Spend **excludes** the following:
    - (a) Cash withdrawal by any method (e.g. Automated Teller Machine, over-the-counter, quasi cash, cash advance.);
    - (b) portfolio products such as Balance Transfer, Quick Cash, Flexi Payment Plan, Auto Balance Conversion.;
    - (c) refunded, disputed, unsuccessful, reversed, unauthorised, fraudulent or unlawful transactions; and
    - (d) any form of fees, costs and charges for services and miscellaneous fees, costs and charges imposed by or incurred by HLB in respect of the Eligible Cards including, without limitation, finance charges, credit card annual fee, late payment charges and government service tax.

**(b) Criteria for Approval Gift**

- (iv) HLB does not have any obligation to inform the Eligible Cardholders in the event the Approval Gift Allocation Cap has been reached;
- (v) Winners will be notified by HLB via SMS, email and/or by way of posting the list of Winners (i.e. masked names and/or masked ID numbers and/or masked Eligible Card numbers) on HLB's Website on or before the respective Notification Date indicated in **Table 2** below;

- (vi) HLB gives no representation nor warranty with respect to the validity, quality or suitability of the Premiere Movie Tickets to the Winners and HLB shall not be responsible to replace any expired/invalid Premiere Movie Tickets. Any request for replacement of such expired/invalid Premiere Movie Tickets shall not be entertained by HLB.
  - (vii) The Premiere Movie Tickets are issued by Golden Screen Cinema ("**GSC**") and any complaint, dispute or claim in relation to the Premiere Movie Tickets shall be settled directly between the Winner and GSC without recourse to HLB. The GSC's terms and conditions in relation to the Premiere Movie Tickets shall apply (as specified under **Clause 6**).
5. For the avoidance of doubt, notwithstanding the above, Eligible Cardholders will also be entitled to participate in the:
- (a) HLB Cards: Frenzy Friday Promotion to receive 50% Cashback as disclosed in the T&Cs link [here](#); or
  - (b) Raya Up Your Shopping! Credit Card Acquisition Promotion to get up to RM200 Cashback or Hummer 20" ABS Luggage Bag as disclosed in the T&Cs link [here](#).
6. Premiere Movie Tickets Terms and Conditions:
- (a) Winners are required to provide the SMS or email confirmation that was sent by HLB to redeem the Premiere Movie Tickets on **1 July 2025** at GSC counter located at GSC IOI City Mall 2 (East) during the Premiere Day ("**Redemption Period**"). HLB and/or GSC shall not be liable for any damages, losses, claims, costs or proceedings incurred or suffered by the Winners as a result of its omission or failure to redeem the Premiere Movie Tickets Terms during the Redemption Period and HLB and/or GSC is under no obligation to replace the Premiere Movie Tickets Terms due to the omission

- or failure of the Winner to redeem the Premiere Movie Tickets Terms during the Redemption Period;
- (b) No minimum spend is required to utilise or redeem the Premiere Movie Tickets as the Premiere Movie Tickets are only valid for Jurassic World Rebirth movie;
- (c) The Premiere Movie Tickets are not exchangeable for cash and cannot be upgraded; and
- (d) HLB and/or GSC reserves the right to change these terms and conditions at any time without prior notice.

#### **GENERAL**

7. By participating in the Promotion, the Eligible Cardholders and Winners agree:
- (a) that they have read, understood and agreed to be bound by the T&Cs herein, the general terms and conditions in the HLB's Cardholder Agreement and the specific terms and conditions applicable to the relevant Eligible Cards available on HLB's Website;
  - (b) that all records of transactions within or outside Malaysia captured by HLB's system within the Promotion Period or related to the Promotion are final and conclusive;
  - (c) that HLB's decision on all matters relating to the Promotion shall be final, conclusive and binding on all the Eligible Cardholders;
  - (d) that the Annual Fee Waiver and/or Premiere Movie Tickets (where applicable) is/are non-transferable to any third party and non-exchangeable for up-front cash, credit, cheque or in kind;
  - (e) to access HLB's Website at regular intervals to view the T&Cs of the Promotion and to ensure they keep up to date with any changes or variations to the T&Cs;
  - (f) that HLB is authorised to disclose or publish on HLB's Website their names (in masked form), ID numbers (in masked form), Eligible Card numbers (in masked form), and entitlement to the Premiere Movie Tickets (where applicable) for the purpose of announcing the winners of the Promotion;
  - (g) to provide their latest and accurate contact details (i.e. mobile number and correspondence/email addresses) to HLB. HLB shall not be held responsible/liable in the event HLB is unable to contact any Eligible Cardholder due to an inaccurate/invalid/outdated mobile number and/or correspondence/email address provided by the Eligible Cardholder and/or Winner or in the event an SMS is unable to be delivered due to any reason whatsoever;
  - (h) that HLB is authorized to disclose the Eligible Cardholders' and/or Winners' personal data, i.e. correspondence/email addresses and/or contact numbers to HLB's third party service provider(s) including Infobip Asia Pacific Sdn. Bhd (201001014145 (898379-U)), DCATALYST Sdn Bhd (200801017996 (819292-U)) and/or GSC as HLB deems fit for the purpose of delivering SMS or email communications to the Eligible Cardholders in relation to the Promotion; and
  - (i) to ensure that all the approved Eligible Cards are valid, active and in good standing and that the Eligible Cardholders shall not be in breach of any of the T&Cs of the Promotion, the general terms and condition in the HLB's Cardholder Agreement and/or the specific terms and conditions of the relevant Eligible Cards throughout the Promotion Period and until the point the Annual Fee Waiver and/or Premiere Movie Tickets (where applicable) are awarded and received.
8. HLB reserves the right to:

- (a) forfeit and/or claw back the Annual Fee Waiver and/or Premiere Movie Tickets (where applicable) in the circumstance where there is a reversal of the Eligible Spend or non-compliance with the T&Cs herein or termination of the Eligible Cards during the Promotion Period and/or at the point of awarding the Annual Fee Waiver and/or Premiere Movie Tickets (where applicable);
  - (b) replace and substitute the Annual Fee Waiver and/or Premiere Movie Tickets (where applicable) with an alternative gift of similar value with prior notice to Eligible Cardholders by way of posting on HLB's Website or in any other manner which HLB deems practical;
  - (c) forfeit and/or claw back the Annual Fee Waiver and/or Premiere Movie Tickets (where applicable) in circumstance where there is any form of abuse which includes payments on behalf of other individuals involving monetary exchange between parties or any detected fraud;
  - (d) add, delete or amend the T&Cs herein, wholly or in part, or to terminate the Promotion with prior notice to the Eligible Cardholders by way of posting on HLB's Website, or by any other methods which HLB deems practical; and
  - (e) decline the eligibility of any Eligible Cardholder for the Annual Fee Waiver and/or Premiere Movie Tickets (where applicable) if HLB reasonably believes such Eligible Cardholder to have performed one or more Eligible Spend transactions in a manner or pattern which HLB deems to be abnormal and/or irregular, and HLB's decision in this matter shall be final and conclusive on all the Eligible Cardholders.
9. HLB shall not be liable and responsible for any failure or delay in the submission and/or processing of the application for Eligible Cards and/or any sales transaction by VISA, Mastercard International, Merchant establishments, postal service providers or any party, which may result in any Eligible Cardholder being omitted from the Promotion.
10. In addition to the terms and conditions stipulated above, the Eligible Cardholders and the Winners agree that in respect of the Promotion, the general terms and conditions in the HLB's Cardholder Agreement and the specific terms and conditions in relation to the relevant Eligible Cards shall be read together with the T&Cs herein. In the event of any discrepancies between these T&Cs and general terms and conditions of the HLB's Cardholder Agreement and/or the specific terms and conditions in relation to the relevant Eligible Cards, the specific T&Cs herein shall prevail to the extent of such discrepancies in respect of the Promotion.
11. In the event of any discrepancies between these T&Cs as compared to the advertising, promotional, publicity and other materials relating to or in connection with the Promotion, the final terms and conditions of this Promotion on HLB's Website shall prevail.
12. The T&Cs herein shall be governed by and construed in accordance with the laws of Malaysia and the Eligible Cardholders and the Winners agree to submit to the exclusive jurisdiction of the Courts of Malaysia.
13. Words denoting one gender include all other genders and words denoting the singular include the plural and vice versa.
