

HLB CARDS: JURASSIC WORLD REBIRTH PROMOTION

Last updated on 17 June 2025

PROMOTION PERIOD

The Hong Leong Bank Berhad's (193401000023 (97141-X)) ("**HLB**") "**HLB Cards: Jurassic World Rebirth Promotion**" ("**Promotion**") commences on **17 June 2025** and ends on **22 June 2025**, both dates inclusive ("**Promotion Period**"), unless specified herein or notified otherwise.

TERMS & CONDITIONS

The terms and conditions applicable to the Promotion ("**T&Cs**") are as follows:

PROMOTION ELIGIBILITY

- 1. The Promotion is open to all existing, Malaysian and non-Malaysian, individual principal **HLB Visa Debit and Credit Cardholders** ("**Cardholders**") to participate during the Promotion Period. New Cardholders refer to those who do not have any HLB Visa debit and credit card with HLB before the Promotion Period. This Promotion is for Eligible Cardholders (as defined as **Clause 3** below) of the T&Cs herein.
- 2. The following Cardholders shall **<u>NOT</u>** be eligible for this Promotion:
 - (a) Cardholders whose HLB Visa debit and credit cards ("**Cards**") are NOT issued in Malaysia;
 - (b) ETC Applicants who have joined HLB Jurassic World Rebirth Credit Card acquisition campaign;
 - (c) Cardholders whose Card accounts are NOT in good standing, inactive, or who are in breach of any of the HLB's General Terms and Conditions of the Cardholder Agreement and the specific Terms and Conditions applicable to the Card at any time during the Promotion Period;
 - (d) Cardholders whose Card accounts are invalid or cancelled at any time during the Promotion Period;
 - (e) Cardholders who have committed or are suspected of committing any fraudulent, unlawful or wrongful acts in relation to any of the facilities granted by HLB; and/or
 - (f) Cardholders who have been declared bankrupt/insolvent (pursuant to a petition either by banks or by any third party) or are subject to any bankruptcy proceedings at any time prior to, during or after the Promotion Period.

PROMOTION MECHANICS

3. To participate in this Promotion, Cardholders must use their Cards to perform the Eligible Transactions (as described under Clauses 4 to 7 below) and fulfil the following Qualifying Criteria (as specified at Table 1 below) ("Qualifying Criteria") during the Promotion Period ("Eligible Cardholders") to win the Promotion Prize (as specified in Table 1 below):

Qualifying Criteria	Promotion Prize
Spend three (3) Eligible Transactions with a minimum amount of Ringgit Malaysia Fifty (RM50) in a single receipt during the Promotion Period (as stated in Clause 10).	Stand a chance to win two (2) units of the GSC 2D Normal Movie Tickets that are located at any GSC locations for Jurassic World Rebirth Movie only.

(a) GSC 2D Movie Tickets ("Movie Ticket")

- (i) Each winner ("**Winner**") will receive two (2) GSC 2D Movie Tickets, which are redeemable solely for the movie "Jurassic World Rebirth". Winners are limited to 250 customers each week (total 500 customers for two (2) weeks) on a first come, first served basis.
- (ii) Valid for one (1) single adult Movie Ticket per redemption. To redeem two (2) units of Movie Tickets, two (2) separate transactions must be performed. This offer is valid at all GSC nationwide cinemas except Aurum Theatre.
- (iii) Redeemable via e-Kiosk or Online Platforms (GSC's Website and GSC Mobile App).
- (iv) Valid for Normal 2D Movie Format only.
- (v) Promo code ("**Promo Code**") validity period is two (2) months. Any requests for extensions will be denied.
- (vi) Promo Code is valid for single redemption only. Select any preferred *Payment Method except Advertiser Pass* and tick '*Do You Have Promo Code?*' at the payment check out page.
- (vii) Booking fees is inclusive and advanced purchase is allowed.
- (viii) This Promo Code is not exchangeable for cash and cannot be upgraded.
- (ix) Promo Code is not eligible for ongoing credit card promotions and hall bookings.
- (x) GSC reserves the right to change these terms and conditions at any time without prior notice.
- 4. **"Eligible Transactions**" for the purpose of this Promotion INCLUDE all retail purchases transacted locally during the Promotion Period.
- 5. Eligible Transactions made by supplementary credit cardholder(s) will also be included in the computation of the Eligible Cardholder's eligibility for the GSC 2D Movie Tickets.
- 6. For Eligible Cardholders who hold both HLB Credit and Debit Card, spending from both cards will be combined and counted towards fulfilling the Qualifying Criteria.
- 7. For the avoidance of doubt, Eligible Transactions shall **EXCLUDE** the following:
 - (a) any retail spends by recurring payment or auto-billing;
 - (b) purchases involving any portfolio products such as Balance Transfer (BT), Quick Cash
 (QC) and Flexi Payment Plan (FPP);



- (c) refunded, disputed, unsuccessful, reversed, unauthorised, fraudulent or unlawful transactions; and/or
- (d) any form of services or miscellaneous fees, including finance charges and fees such as credit card annual fee, late payment charges and government service tax, imposed by HLB.
- 8. The total Movie Tickets allocation for this Promotion is capped at **one thousand (1,000)** units during the Promotion Period. HLB has no obligation to inform the Eligible Cardholders should the total Movie Tickets allocation have reached its limit. Eligible Cardholders will be eligible to win up to a <u>maximum of two (2) GSC 2D Movie Tickets only</u> every Friday to Sunday on **a first come, first served basis** premised on the earliest time which an Eligible Cardholder fulfils the Qualifying Criteria.

For the avoidance of doubt, in the event of a tie (i.e. where there is more than **one (1)** Eligible Cardholder who have fulfilled the Qualifying Criteria on the same date ("**Date of Tie**") and on the same time during the Promotion Period and would have been the Winner if not for the tie), the GSC 2D Movie Tickets will be awarded to the Eligible Cardholders in the sequence based on the following hierarchy of criteria ("**Tie-Breaker**") as set out in Table 2 below:

Table 2	

Priority	Tie Breaker Criteria	
1	The GSC 2D Movie Tickets will be awarded to the Eligible Cardholder who fulfils the Qualifying Criteria at an earlier time of the Date of Tie.	
2	If there is a tie in Priority (1) (i.e. same date), the GSC 2D Movie Tickets will be awarded to the Eligible Cardholder with the highest amount spent on the Eligible Transactions on the Date of Tie.	
3	If there is a tie in Priority (2) (i.e. same amount), the GSC 2D Movie Tickets will be awarded to the Eligible Cardholder with the highest transaction counts based on the Eligible Transactions performed on the Date of Tie.	

9. The assignment of the Eligible Transactions shall be based on the Merchant Category Code and details of a merchant ("**MCC**"), and is performed by the respective merchants' acquiring bank ("**Acquiring Bank**") and it is the responsibility of the particular Acquiring Bank to assign the correct MCC. For the avoidance of doubt, HLB shall not be held responsible for any incorrect assignment of MCC by the Acquiring Bank that may result in non-fulfilment of the Qualifying Criteria.

PROMOTION FULFILMENT AND WINNERS' SELECTION

 The two (2) GSC 2D Movie Tickets will be sent to the Winner's email and/or by way of posting the list of winners (i.e. masked names and/or masked ID numbers and/or masked Eligible Card numbers) on HLB's Website on a first come, first served basis from the end of the Promotion Period ("**Reward Period**") indicated in the **Table 3** below;

At the time of rewarding the Movie Tickets, the Card account of the Eligible Cardholders must be valid and/or active, in good standing and must not be in breach of any of these T&Cs, HLB's General Terms and Conditions of the Cardholder Agreement and the specific Terms and Condition applicable to the Card during the Promotion Period and up to the Reward Period, failing which the Eligible Cardholders will be disqualified automatically.

- 11. Eligible Transactions must be transacted during and within the Promotion Period. Any Eligible Transactions transacted after the Promotion Period will not be taken into account.
- 12. HLB gives no representation nor warranty with respect to the validity, quality or suitability of the GSC 2D Movie Tickets to the Winners and HLB shall not be responsible to replace any expired/invalid GSC 2D Movie Tickets. Any request for replacement of such expired/invalid Premiere Movie Tickets shall not be entertained by HLB.
- 13. The GSC 2D Movie Tickets are issued by Golden Screen Cinema ("**GSC**") and any complaint, dispute or claim in relation to the GSC 2D Movie Tickets shall be settled directly between the Winner and GSC without recourse to HLB. The GSC's terms and conditions in relation to the GSC 2D Movie Tickets shall apply (as defined under **Clause 3**).
- 14. HLB and/or GSC shall not be liable for any damages, losses, claims, costs or proceedings incurred or suffered by the Eligible Cardholders/Winners as a result of their participation in the Promotion and/or redemption and/or utilisation of the GSC 2D Movie Tickets.

GENERAL

- 15. By participating in the Promotion, the Eligible Cardholders/Winners:
 - (a) confirm that they have read, understood and agreed to be bound by the T&Cs herein, HLB's General Terms and Conditions of the Cardholder Agreement and the specific Terms and Conditions applicable to the Card available at HLB's website at www.hlb.com.my ("HLB's Website");
 - (b) agree that all records of the Eligible Transactions captured by HLB's system for the purpose of this Promotion are accurate and final;
 - (c) agree that HLB's decision on all matters relating to this Promotion shall be final, conclusive and binding on all the Eligible Cardholders/Winners;
 - (d) agree that the GSC 2D Movie Tickets are non-transferable to any third party and nonexchangeable for up-front cash, credit, cheque or in kind;
 - (e) agree to access HLB's Website at regular intervals to view the T&Cs of this Promotion to ensure they keep up-to-date with any changes or variations to these T&Cs;
 - (f) that HLB is authorised to disclose or publish on HLB's Website their names (in masked form), ID numbers (in masked form), Eligible Card numbers (in masked form), and entitlement to the GSC 2D Movie Tickets (where applicable) for the purpose of announcing the winners of the Promotion;



- (g) to provide their latest and accurate contact details (i.e. mobile number and correspondence/email addresses) to HLB. HLB shall not be held responsible/liable in the event HLB is unable to contact any Eligible Cardholder due to an inaccurate/invalid/outdated mobile number and/or correspondence/email address provided by the Eligible Cardholder or in the event an SMS is unable to be delivered due to any reason whatsoever;
- (h) agree to authorise HLB to disclose their personal data i.e. contact numbers and email addresses to its authorised 3rd party vendor including Infobip Asia Pacific Sdn Bhd (201001014145 (898379-U)) and/or DCATALYST Sdn Bhd (200801017996 (819292-U)) for the purpose of communication/notification in relation to this Promotion; and
- (i) agree to be liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in the Promotion.
- 16. HLB reserves the right to:
 - (a) disqualify any Eligible Cardholders/Winners who have performed the Eligible Transactions in a manner or pattern which HLB deems to be abnormal, irregular and/or is indicative of an attempt to obtain an unfair advantage over other Eligible Cardholders;
 - (b) forfeit and/or claw back the GSC 2D Movie Tickets where there is reversal of the Eligible Transactions or termination of the Cards or non-compliance to the T&Cs herein during the Promotion Period and/or at the point of awarding the GSC 2D Movie Tickets; and
 - (c) add, delete or amend the T&Cs herein, wholly or in part, or to terminate the Promotion, by way of posting on HLB's Website or in any other methods which HLB deems practical and to give prior notice to the Eligible Cardholders/Winners.
- 17. HLB shall not be liable and responsible for any failure or delay in the submission and/or processing of the Eligible Transactions by Visa International Incorporated, Mastercard International, merchant establishments, or any party in which may result in the Eligible Cardholders being omitted from the Promotion.
- 18. The T&Cs herein shall be governed by and construed in accordance with the laws of Malaysia and the Eligible Cardholders agree to submit to the exclusive jurisdiction of the Courts of Malaysia.
- 19. In addition to the terms stipulated above, Eligible Cardholders agree that HLB's General Terms and Conditions of the Cardholder Agreement and the specific Terms and Condition applicable to the Card shall be read together with the T&Cs herein as an entire agreement. Any discrepancies between these T&Cs and HLB's General Terms and Conditions of the Cardholder Agreement or the specific Terms and Condition applicable to the Card, the specific terms in these T&Cs shall prevail to the extent of such discrepancies.
- 20. In the event of any discrepancies between these T&Cs as compared to the advertising, promotional, publicity and other materials relating to or in connection with the Promotion, the final terms and conditions on HLB's Website shall prevail.
