

## **HLB CARDS: RM1 MILLION EXPERIENCE PROMOTION**

Last updated on 30 April 2026

### **PROMOTION PERIOD**

The Hong Leong Bank Berhad's (193401000023 (97141-X)) ("**HLB**") "**RM1 Million Experience Promotion**" ("**Promotion**") commences on **3 December 2025** and ends on **2 March 2026**, both dates inclusive ("**Promotion Period**"), unless notified otherwise.

### **TERMS & CONDITIONS**

The following sets out the terms and conditions applicable to the Promotion ("**T&Cs**").

### **ELIGIBILITY**

1. The Promotion is open to all new and existing, Malaysian and non-Malaysian, individuals with principal **HLB Visa Credit Cardholders** and **HLB Visa Debit Cardholders** ("**Cardholders**") to participate during the Promotion Period. New Cardholders refer to those who do not have any HLB credit or debit card before the Promotion Period. Registration is not required for participation under this Promotion.
2. The following persons shall not be eligible to participate in this Promotion:
  - (a) Cardholders whose HLB Visa credit or debit cards (collectively known as the ("**Card**") which are NOT issued in Malaysia;
  - (b) Cardholders whose Card accounts are NOT in good standing, inactive, or who are in breach of HLB's General Terms and Conditions of the Cardholder Agreement and/or the specific Terms and Condition in relation to the Card at any time during the Promotion Period, Prize Fulfilment Period (as defined under Clause 23) and Grand Prize Fulfilment Period (as defined under Clause 19);
  - (c) Cardholders whose Card accounts are invalid or cancelled at any time during the Promotion Period;
  - (d) Cardholders who have committed or are suspected of committing any fraudulent, unlawful or wrongful acts in relation to any of the facilities granted by HLB or have been declared bankrupt or are subject to any bankruptcy proceedings at any time prior to, during or after the Promotion Period; and
  - (e) Cardholders who are not users of HLB Connect App.

### **PROMOTION MECHANICS**

3. To participate in this Promotion, Cardholders ("**Eligible Cardholders**") are required to meet the qualifying criteria ("**Qualifying Criteria**") below using their Card during the Promotion Period to earn entries ("**Contest Entries**") for the Promotion:

#### **Qualifying Criteria:**

Eligible Cardholders must meet the minimum number ("**Qualifying Swipes**") of Eligible Transactions (as defined under Clauses 10 to 13 below), with a minimum amount of Ringgit Malaysia Fifty (RM50) per transaction, within a calendar day during the Promotion Period to earn Contest Entries. The number of Contest Entries earned from Qualifying Swipes shall vary in accordance with the type of Card used and Additional Condition(s), as stipulated in Tables 1 and 2 below:

Note: If the Eligible Transaction(s) fulfil more than 1 Additional Condition (refer to column 3 of Table 1), the number of Contest Entries will be awarded in accordance to the Additional Condition which awards the Eligible Cardholder the highest number of Contest Entries. Additional Conditions do not apply to Eligible Transactions made with HLB Visa Debit Card.

6. **The following are the definition of Eligible Transactions under Additional Condition(s):**
- (i) **Mobile Pay ("Mobile Pay"):** Eligible Transactions performed via Apple Pay, Google Pay or Samsung Pay.
  - (ii) **Special Transactions ("Special Transactions") include:**
    - (a) Eligible Transactions made in foreign currency via point-of-sale at physical outlets located outside Malaysia, excluding online purchases; or
    - (b) All Eligible Transactions made on Special Day(s) as set out below:

7. For the avoidance of doubt, an Eligible Cardholder may perform multiple Qualifying Swipes (i.e. 10 Qualifying Swipes) in a calendar day to increase his/her number of Contest Entries. Contest Entries awarded will be calculated based on the highest possible combination, rounded down to the nearest number of Qualifying Swipes which award Contest Entries as stipulated in Tables 1 and 2 above. A maximum daily capping (“**Daily Cap**”) of one hundred eighty (180) Contest Entries per day per Eligible Cardholder shall apply.

10. Eligible Transactions shall INCLUDE all retail and online purchases transacted locally and internationally during the Promotion Period (“**Eligible Transactions**”) **except** those listed under the Merchant Category Code (“**MCC**”) as specified in Table 5 below:

Note: The assignment of the Eligible Transaction based on the MCC descriptions for the merchant is performed by the respective merchant’s acquiring bank, and it is the responsibility of the particular acquiring bank to assign the correct MCC. Eligible Transactions will not be qualified in the event of an incorrect assignment of MCC by the acquiring bank.

11. Eligible Transactions made in currencies other than Ringgit Malaysia (“**RM**”) will be converted to and computed in RM based on the conversion rate determined by HLB at the time of the transaction.
12. Eligible Transactions made by supplementary credit cardholder(s) under a principal credit cardholder’s account will also be included in the computation of the Eligible Cardholder’s eligibility for the Grand Prize and Daily Cashback Prize.
13. Eligible Transactions shall further **EXCLUDE** the following:
- (a) purchases involving any portfolio products such as Balance Transfer (BT), Quick Cash (QC) and Flexi Payment Plan (FPP);
  - (b) refunded, disputed, unsuccessful, reversed, unauthorised, fraudulent or unlawful transactions; and/or
  - (c) any form of services or miscellaneous fees, including finance charges and fees such as credit card annual fee, late payment charges and government service tax, imposed by HLB.
14. For the avoidance of doubt, all Eligible Transactions must be posted no later than five (5) days from the date of the Eligible Transactions performed in order for the Cardholders to earn the Contest Entries. HLB shall not be liable and responsible for any failure or delay in the submission and/or processing of the Eligible Transactions by Visa International Incorporated, merchant establishments, or any party in which may result in the Cardholders being omitted from this Promotion.
15. HLB shall not be liable and responsible for any failure or delay in processing the Eligible Transactions by Visa International Incorporated, merchant establishments, system downtime, technical failure of the terminal or any party in which may result in the Eligible Transaction and its associated transaction(s) being omitted from this Promotion.
16. Eligible Cardholders shall be entitled to a maximum of one Daily Cashback Prize per Eligible Cardholder per day.

17. For Eligible Cardholders who hold multiple Cards, the computation of the Qualifying Swipes shall be combined across multiple Cards. Qualifying Swipes from HLB Visa Credit Card(s) cannot be combined with Qualifying Swipes from HLB Visa Debit Card(s), or vice versa.

**Grand Prize:**

18. Eligible Cardholders' Contest Entries will be randomly selected (the "**Shortlisting Process**") via an automated selection system ("**Randomizer**") based on all Contest Entries earned from the Promotion Period. If a Cardholder's Contest Entry is selected by the Randomizer ("**Shortlisted Cardholders**"), they are then required to complete the Q&A Process (as set out under Clauses 24 & 25 below) in order to win the Grand Prize.
19. The Grand Prize is fulfilled via the details ("**Fulfilment Details**") in Table 6 below:

Cash	Cash will be fulfilled via crediting of sum of Cash prize monies into the Grand Prize winners' (" <b>Grand Prize Winner</b> ") HLB savings account or HLB Current account within the Grand Prize Fulfilment Period.

20. The Grand Prize Winner will be contacted by HLB's representative for which the Grand Prize Winner is required to:
- (i) Provide his/her HLB savings account number or HLB current account number for the purpose of crediting the Grand Prize; or
  - (ii) Open an HLB Savings Account or HLB Current Account for item (i) if the Grand Prize Winner does not have such account with HLB.

Failure to complete or provide the above information within fourteen (14) calendar days after Winners Announcement Date (as defined under Clause 29 may result in the forfeiture of the Grand Prize from the Grand Prize Winner.

#### **Daily Cashback Prize:**

21. Eligible Cardholders' Contest Entries will be randomly selected (the "**Shortlisting Process**") via an automated selection system ("**Randomizer**") based on Contest Entries earned in each calendar day during Promotion Period. Contest Entries earned in a calendar day shall be used only for the Shortlisting Process for the Daily Cashback Prize of the same day.
22. Eligible Cardholders whose Contest Entries have been selected ("**Shortlisted Cardholders**") are then required to complete the Q&A Process (as set out under Clauses 24 & 25 below) with correct answer(s) in order to win or become the winner ("**Cashback Winner**") the Daily Cashback Prize.
23. The Daily Cashback Prize will be fulfilled via crediting of cashback into the Cashback Winners' principal Card accounts within seventy-five (75) days after the end of Promotion Period ("**Prize Fulfilment Period**").

#### **Question & Answer Process ("Q&A")**

24. An In-App Push ("**IAP**") notification via HLB Connect App will be sent to the Shortlisted Cardholder, requesting them to answer one (1) simple question ("**Q&A**") pertaining to the Promotion within a time limit (i.e. forty-eight (48) hours from time of notification).

25. Shortlisted Cardholders are required to click on the website link from the IAP notification in HLB Connect App, where it will redirect the Cardholders to HLB's contest website outside of HLB Connect App to select one (1) correct answer within the given time limit. A Shortlisted Cardholder who answers the Q&A correctly within the time limit shall be the winner ("**Winner**") of the prize which he/she is shortlisted for.
26. Should there be more than one (1) answer entry submission from the same Shortlisted Cardholder, only the earliest answer submitted will be valid.
27. Submission of answer(s) after the given time limit will be deemed invalid.
28. It is the obligation of the Winner to provide their latest and valid contact details and email addresses to HLB within the Promotion Period and HLB shall not be responsible in the event HLB is unable to reach the Promotion Winners for any reasons whatsoever. HLB shall not be held liable in the event of any technical issues, delayed notifications, or failure to receive the IAP due to device settings or connectivity. It is the responsibility of the Shortlisted Cardholders to ensure their HLB Connect App notifications are enabled and to check the HLB's website for updates or alternative instructions, where applicable.

#### **PROMOTION FULFILMENT**

29. At the time of rewarding the Grand Prize and/or Daily Cashback Prize (collectively known as "**Promotion Prize**"), the Card accounts of Winners must be valid and/or active, in good standing and must not be in breach of any of these T&Cs, HLB's General Terms and Conditions of the Cardholder Agreement and the specific Terms and Condition in relation to the Card during the Promotion Period and up to the Grand Prize Fulfilment Period, failing which the Winners will be disqualified automatically.
30. Winners will be notified by HLB by way of posting the list of Winners (Principal Cardholders' name and masked NRIC Number) in the Promotion Website (<http://www.hlb.com.my/1million>) within ninety (90) working days after the Promotion Period ("**Winners Announcement Date**") or by way of notification via IAP or email within five (5) working days after HLB has credited the Promotion Prize to the Winners' Card accounts.
31. It is essentially the obligation of the Winners to inform HLB within fourteen (14) days after the Winners Announcement Date in the event of non-receipt of the Promotion Prize, failing which the Winners are deemed to have received the Promotion Prizes and any complaints of non-receipt thereafter shall not be entertained by HLB.
32. In the event HLB has a prize giving ceremony for the Grand Prize, the Winner will be required to attend at his/her own cost and expense to collect the Grand Prize and HLB shall not be responsible to bear such costs. In the event the Winner is not able to attend the prize giving ceremony, the Winner can nominate a representative to be present at the prize giving ceremony to accept the Prize on his/her behalf and the terms set herein shall be applicable to the representative. The representative will be required to present a written authorization from the Winner and photocopy of the Winner's NRIC (front and back).

33. HLB shall reserve the right to use the names and/or photographs of the Winners as materials for the purposes of publicity, without any prior notice to the Winners. The Winners shall not be entitled to claim ownership or other forms of compensation on the materials.
34. In the event a Winner chooses not to accept any of the Promotion Prizes, no replacement or exchange of the Promotion Prizes will be entertained.

#### **GENERAL**

35. By participating in this Promotion, the Eligible Cardholders agree:
  - (a) that they have read, understood and agree to be bound by these T&Cs herein, the specific Terms and Conditions in relation to the Card and the HLB's General Terms and Conditions of the Cardholder Agreement available at HLB's website at [www.hlb.com.my](http://www.hlb.com.my) ("**HLB's Website**");
  - (b) that all records of the Eligible Transactions captured by HLB's system for the purpose of this Promotion are final;
  - (c) that HLB's decision on all matters relating to this Promotion shall be final, conclusive and binding on all Eligible Cardholders;
  - (d) that the Promotion Prize is non-transferable to any third party and non-exchangeable for any credit, cheque or in kind;
  - (e) to access HLB's Website at regular intervals to view the T&Cs of this Promotion to ensure that they keep up-to-date with any changes or variations to the T&Cs;
  - (f) to authorise HLB to disclose their personal data i.e., name, contact numbers, address to its authorised 3<sup>rd</sup> party vendor including Infobip Asia Pacific Sdn Bhd (201001014145 (898379-U)) and any other vendor and/or supplier(s) appointed by HLB for the purpose of communication and fulfilment of Promotion Prizes for this Promotion; and
  - (g) to be liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in this Promotion.
36. HLB reserves the right to:
  - (a) disqualify any Eligible Cardholders who have performed the Eligible Transactions in a manner or pattern which HLB deems to be abnormal, irregular and/or is indicative of an attempt to obtain an unfair advantage over other Eligible Cardholders;
  - (b) forfeit and/or claw back the Promotion Prize where there is reversal of the Eligible Transactions, as applicable, or termination of the Card during the Promotion Period and/or at the point of awarding the Promotion Prize or non-compliance to the T&Cs herein; and
  - (c) add, delete or amend the T&Cs herein, wholly or in part, or to terminate this Promotion, by way of posting on HLB's Website or in any other methods which HLB deems practical, in order to give prior notice to the Eligible Cardholders; and
  - (d) To amend the Grand Prize at its discretion, with notice published on the HLB's Website and it shall be the responsibility of the Eligible Cardholders to check for such updates.
37. These T&Cs herein shall be governed by and construed in accordance with the laws of Malaysia and the Cardholders agree to submit to the exclusive jurisdiction of the Courts of Malaysia.

38. In addition to the terms stipulated above, Eligible Cardholders agree that HLB's General Terms and Conditions of the Cardholder Agreement and the specific Terms and Conditions in relation to the Card shall be read together with the T&Cs herein as an entire agreement. Any discrepancies between these T&Cs and HLB's General Terms and Conditions of the Cardholder Agreement or the specific Terms and Conditions in relation to the Card, the specific terms in these T&Cs shall prevail to the extent of such discrepancies.
39. In the event of any discrepancies between these T&Cs as compared to the advertising, promotional, publicity and other materials relating to or in connection with this Promotion, the final terms and conditions on HLB's Website shall prevail.
