CAMPAIGN PERIOD

The Hong Leong Bank Berhad's (Company No. 193401000023 (97141-X)) ("HLB") "HLB New-To-Bank Private & Priority Banking MYR Unit Trust Fixed Deposit (UTFD) Campaign - Promotional MYR Fixed Deposit Rates at 10.88% for 3 months" ("Campaign") commences on 17 October 2025 and ends on 31 December 2025, both dates inclusive of ("Campaign Period"), unless otherwise notified.

TERMS & CONDITIONS

The following terms and conditions apply to the Campaign ("**T&Cs**"):

ELIGIBILITY

- 1. The **Campaign** is only open for participation to HLB's New Private & Priority Banking customers, including Malaysian and Non-Malaysian individuals.
- 2. For the purpose of this Campaign:
 - a) **New Customers** refer to individual primary accountholders who do not have any facilities, current or savings accounts or investments with HLB prior to the commencement date of the Campaign Period.
 - b) "Priority Banking customers" refer to individual customers with a total combined Asset Under Management ("AUM") and/or investment of Ringgit Malaysia Three Hundred Thousand (RM300,000) and above, and accepted as a Priority Banking customer by HLB.
 - c) "Private Banking customers" refers to existing individual customers with a total combined Asset Under Management ("AUM") and/or investment of Ringgit Malaysia Three Million (RM3,000,000) and above, and accepted as a Private Banking customer by HLB.
 - d) AUM refers to total deposit in any Fixed Deposit Account (FD), Savings Account (SA), Current Account (CA), Foreign Currency Account (FCA) and/or the amount of investment in any Unit Trust Funds and/or Structured Products with HLB at any one time ("Account") under Primary Accountholder's name.
- 3. The following individuals are not be eligible to participate in the Campaign:
 - a) Customers who have committed or are suspected of committing any fraudulent, unlawful or wrongful acts in relation to any of the facilities granted by HLB;
 - b) Individuals who are facing bankruptcy proceedings, or have been declared bankrupt either before, during or after the Campaign Period;
 - c) Customers who are in breach any of HLB and Hong Leong Islamic Bank Berhad (Company No. 200501009144 (686191-W)) ("HLISB") General Terms and Conditions of Account and/or General Terms and Conditions of unit trust accounts, at any time before or during the Campaign Period; or
 - d) Employees of HLB, HLISB or any entity within the Hong Leong Group.

CAMPAIGN MECHANICS



- 4. Eligible Customers may enjoy Promotional FD Rates as set out in **Table 1** below, subject to meeting the conditions specified in this T&Cs.
- 5. The participating Fixed Deposit ("**FD**") accounts ("**Participating FD Accounts**") for this Campaign are as follows:
 - a) Conventional FD;
 - b) Senior Savers Flexi FD; and
 - c) Priority Banking Premium FD.
- 6. To qualify for the Promotional FD Rate as set out in **Table 1** below, the Customers must during the Campaign Period:
 - a) invest or top up a minimum of Ringgit Malaysia Twenty Thousand (RM20,000) ("Minimum UT Investment Amount") in any of the selected Unit Trust Fund as stated in Appendix 1 ("Selected UT"), subject to payment of a Minimum UT Sales Charge as defined in Table 1 below; and
 - b) open a Participating FD Accounts with HLB and place an amount not exceeding the Maximum FD Placement Amount as defined in **Table 1** below, into the Participating FD Accounts ("**FD Placement Amount**").
- 7. Customers who meet the criteria in Clauses 6 above shall be deemed "Eligible Customers". Investment made in the form of regular savings plan is not eligible under this Campaign.

- 9. Based on **Table 2** above, an Eligible Customer investing RM20,000 in a Selected UT during the Campaign Period may place up to RM10,000 in a Participating FD Account at the 10.88% p.a. Promotional FD Rate for a 3-months tenure.
- 10. The UT order date shall be deemed as the UT investment date for the Selected UT funds listed in Appendix 1.
- 11. FD Placement Amount deposited into the Participating FD Accounts must be made within seven (7) working days from the UT investment date. Both UT investment and FD placement must be made within the Campaign Period.
- 12. The total fund size limit for the Promotional FD Rates under this Campaign is **Ringgit Malaysia One Hundred Million (RM100,000,000)** ("**Fund Size Limit**"), subject to first-come, first-served basis,
- 13. Promotional FD Rate apply only to placement made with **New Funds** (as defined in Clause 14 below) only.
- 14. For the purpose of this Campaign, the following are considered as **New Funds**:
 - a) Financial Process Exchanges ("**FPX**"), instant transfer, interbank GIRO, telegraphic transfer from other banks during the Campaign Period; or
 - b) Local cheque or banker's cheque from other banks which are deposited into HLB Current Account or Savings Account ("CASA") of the Eligible Customers before depositing the said fund into the Participating FD Accounts, during the Campaign period.
- 15. The following are **NOT** be considered as "**New Funds**":
 - a) maturing FD or prematurely withdrawn FD from any existing FD Accounts with HLB;
 - b) transfer of funds, i.e., transfer of funds from another HLB account (whether CASA, FD or General Investment Account);
 - c) inter or intra-branch transfer or third party account transfer within HLB;
 - d) proceeds from the redemption of equity, unit trust funds, bonds, sukuk or another HLB FD accounts re-deposited into the Participating FD Accounts; and
 - e) withdrawals from the savings pursuant to the Employees Provident Fund Act 1991.
- 16. This Campaign cannot combine with any other on-going HLB promotions.
- 17. Each Eligible Customer is entitled to one (1) Promotional FD Rate per UT Investment made.
- 18. The Eligible Customer must be either the primary accountholder or the secondary accountholder for both the Participating FD Account and the UT Investment Account.
- 19. In the event any FD Placement Amount exceeds the prescribed Maximum FD Placement Amount as set out in Table 1 above or if the Fund Size Limit is reached, then such FD Placement Amount shall be subject to the prevailing FD board rates as determined by HLB.
- 20. Eligible Customers without a CASA prior to the Campaign Period are required to open one and nominate a CASA maintained with HLB under the same name and signature requirement as the Participating FD Account ("Nominated CASA") for the purpose of



crediting the FD interest earned under this Campaign.

- 21. Interest earned for the Participating FD Accounts shall be credited into the Eligible Customers' Nominated CASA upon FD maturity.
- 22. Upon maturity, the Participating FD Accounts will be auto-renewed at the prevailing FD board rates, with interest earned credited to the Nominated CASA.
- 23. No interest will be paid on partially withdrawn or prematurely withdrawn FD, regardless of the tenure completed.
- 24. Subject to Clause 23 above, partial withdrawal of the FD is allowed in multiples of **Ringgit Malaysia One Thousand (RM1,000)**.
- 25. FD placement under this Campaign cannot be used as collateral for any credit facility obtained or to be obtained. This excludes other FDs used as collateral to secure HLB issued credit cards. Please refer to the Secured Credit Card with Fixed Deposit Terms & Conditions for details.
- 26. In the event the Eligible Customers exercise their cooling-off right or any transaction of the UT Investment is rejected or cancelled by any parties for whatsoever reason, Eligible Customers shall NOT be entitled to the Promotional FD Rates. Accordingly, the FD will be uplifted and no interest shall be paid in accordance to Clause 23 above.
- 27. HLB reserves the right to update the list of eligible funds whenever there is any new or change to the fund list.

GENERAL

- 28. By participating in the Campaign, Eligible Customers:
 - a) confirm that they have read, understood and agreed to be bound by the T&Cs herein; the General Terms and Conditions of Accounts, the terms and conditions applicable to the Participating FD Accounts, and any other relevant terms and conditions that HLB may impose from time to time by way of notice to the Customers;
 - b) agree that all records of the fulfilment of the eligibility requirements captured by HLB's system during the Campaign Period are final and conclusive;
 - c) agree that HLB's decision on all matters relating to the Campaign are final, conclusive and binding;
 - d) undertake to regularly visit HLB's websites at (<u>www.hlb.com.my</u>) ("HLB's Website") to view the latest T&Cs of the Campaign and stay informed of any updates and changes;
 - e) acknowledge that any benefits received under the Campaign are non-transferable and non-exchangeable for up-front credit, cheque or benefit in- kind; and
