CHECKOUT AND PAY FOR UNIFI USING FPX ("PROMOTION")

PROMOTION TERMS AND CONDITIONS

ORGANISER

- The Promotion is organised by PAYMENTS NETWORK MALAYSIA SDN. BHD. (Company No.:836743-D) ("PayNet") and TELEKOM MALAYSIA BERHAD (Company No. 128740-P) ("TM") (collectively referred to as "Organisers").
- 2. By participating in the Promotion, participants are taken to have read, understood and agreed to abide by and be bound by these terms and conditions of the Promotion, the Data Protection & Privacy Notice as detailed below, and all amendments, additions, replacements deletions and modifications hereto ("Terms and Conditions") as may be made from time to time by the Organisers and shall be bound by them and abide by the decision of the Organisers.
