

#DREAMCRUISESGAMESET FACEBOOK CONTEST

CONTEST PERIOD

1. The Hong Leong Bank (“HLB”) and Genting Cruise Lines (“GCL”) “#DreamCruisesGameSet Facebook Contest” (“Contest”) commences on 1 May 2019 at 00:00:00 hours (12:00 a.m.) and ends on 31 May 2019 at 23:59:59 hours (11:59 p.m.), inclusive of both dates (“Contest Period”), unless notified otherwise.

CONTEST ELIGIBILITY

2. The Contest is open to all Malaysians residing in Malaysia who are eighteen (18) years old and above (“Participants”). For the avoidance of doubt, Malaysians refer to individuals who are with or without any product holdings with HLB prior to the Contest Period.

CONTEST MECHANICS

3. To participate in the Contest, Participants are required to:

CONTEST PRIZE WINNERS’ SELECTION & FULFILMENT OF CONTEST PRIZE
