

**HONG LEONG BANK BERHAD  
HONG LEONG DEBIT CARD PROMOTION WITH LA JUICERIA**

**PROMOTION PERIOD**

The Hong Leong Bank Berhad's (97141-X) ("Bank") "**Hong Leong Debit Card Promotion with La Juiceria**" ("Promotion") commences on **3 November 2017** and ends on **31 December 2017**, both dates inclusive ("Promotion Period"), unless notified otherwise.

**Terms & Conditions**

**The following sets-out the terms and conditions applicable to the Promotion ("T&Cs"):-**

**ELIGIBILITY**

1. This Promotion is open to all Malaysian and non-Malaysian individual Hong Leong Debit Cardholders including Mach Debit Cardholders ("Cardholders")
2. This Promotion is **NOT** applicable to Hong Leong Islamic Debit Card-i customers.

**PROMOTION MECHANICS**

3. Cardholders who fulfil the following prescribed criteria by using their Hong Leong Debit Cards or Mach Debit Cards every Friday, Saturday & Sunday (including Public Holidays) at the selected merchants as set-out in the table below ("Participating Merchants") throughout the Promotion Period ("Eligible Cardholders") shall be eligible to enjoy the following promotions, subject to the terms & conditions stipulated by the Participating Merchants. Public Holidays shall refer to such days declared as public holidays in the whole of Malaysia.

6. This Promotion is subject to prevailing service and/or government tax or other tax or levies where applicable, unless stated otherwise.
7. This Promotion is not exchangeable for cash nor can it be used in conjunction with other promotional programs, promotions, discounts, vouchers or privilege cards available at Participating Merchants unless stated otherwise.
8. Participating Merchants may have its own terms and conditions applicable to the supply, redemption, utilization and/or provision of this Promotion or in connection with the Promotion (“Participating Merchant’s T&CS”).
9. Participating Merchants reserve the right to change the relevant details and the Merchant’s T&Cs in relation to the Promotion at any time without prior notice. Cardholders are advised to check the details and Merchant’s T&Cs with the staff of the Participating Merchants.

#### **GENERAL**

10. By participating in this Promotion, the Cardholders have and shall be deemed to have:
  - (a) read, understood and agreed to be bound by the T&Cs herein;
  - (b) agreed to access the Bank’s Website at [www.hlb.com.my](http://www.hlb.com.my) (“Bank’s Website”) at regular time intervals to view the T&Cs and to ensure the Cardholders are kept up-to-date on any changes or variations to the T&Cs;
  - (c) agreed that this Promotion is not exchangeable for up-front cash, credit, cheque or benefit-in-kind; and
  - (d) agreed that the Bank’s and Participating Merchants’ decision on all matters relating to this Promotion shall be final, conclusive and binding on all Eligible Cardholders and no further correspondence and/ or appeal to dispute the Bank’s decision shall be entertained.

12. The Bank is not affiliated with Participating Merchants and makes no representation or warranty with respect to the quality and suitability of products and services offered. 13. The Cardholders are liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in this Promotion.

The T&Cs herein, General Terms and Conditions of Accounts, Debit Card Terms and Conditions or any relevant terms and conditions that the Bank may specify from time to time are read as an entire agreement and if there is any discrepancy between the T&Cs herein and the General Terms and Conditions of Accounts and Debit Card Terms and Conditions, the specific T&Cs herein shall prevail to the extent of such discrepancy.

15. The Bank reserves the right :
  - (a) to add, delete, suspend or vary the T&Cs contained herein, either wholly or in part, or to suspend or terminate this Promotion at the Bank's sole discretion with prior notice by way of posting on the Bank's Website or in any other manner deemed suitable by the Bank in order to give **twenty-one (21)** calendar days' prior notice to the Cardholders; and
  - (b) to substitute this Promotion with alternative items of similar value, at its absolute discretion,
16. In the event of any discrepancy between the T&Cs as compared to any advertising, promotional, publicity and other materials relating to or in connection with this Promotion, the final T&Cs on the Bank's Website shall prevail.
17. The T&Cs shall be governed by and construed in accordance with the laws of Malaysia and the Cardholders hereby agree to submit to the jurisdiction of the Courts of Malaysia.
