

## **TERMS AND CONDITIONS**

### **Organizer & Qualifications**

1. The **Texas Chicken/MyDebit "WAVE & GET With MyDebit"** ["**Campaign**"] is jointly organized by TEXAS CHICKEN (MALAYSIA) SDN BHD (986113-P) and PAYMENTS NETWORK MALAYSIA SDN BHD (836743-D) [collectively referred to as "**The Organizer**"]. This Campaign is open to all Texas Chicken customers who is the cardholders of Automated Teller Machine ["**ATM**"] MyDebit Cards issued by participating banks that offered MyDebit in Malaysia ["**the Customers**"].
