

## Fuel & Win with Visa at PETRONAS TERMS AND CONDITIONS

### CAMPAIGN PERIOD

1. Fuel & Win with Visa at PETRONAS (“Campaign”) shall commence on 01 June 2019 at 00:00:00 hours (12:00AM Malaysian time) and ends on 31 August 2019 at 23:59:59 hours (11:59PM Malaysian time), both dates inclusive (“Campaign Period”), unless specified herein or notified otherwise.
2. Fuel & Win with Visa at PETRONAS (“Campaign”) is in joint promotion by PETRONAS Dagangan Berhad (“PDB”) and Visa International (Asia Pacific) LLC – Malaysia Representative Office (“Visa”) (collectively, the “Organizer”) and is subject to the terms and conditions contained herein.

### TERMS AND CONDITIONS

The following sets out the terms and conditions applicable to the Campaign (“T&Cs”).

### ELIGIBILITY

1. The Contest is open to:
  - all new and existing principal or supplementary cardholder(s) of Hong Leong Bank Visa Credit OR Debit issued in Malaysia by Hong Leong Bank Berhad (“Participants”).
  - all Setel application users (PETRONAS e-payment solution) who are Hong Leong Bank Visa Credit OR Debit cardholders that are residing in Wilayah Persekutuan, Selangor and Putrajaya.
2. The Campaign is open to all Participants, except for the following category of persons who are **NOT ELIGIBLE** to participate in this Campaign:
  - Permanent / Contract employees of the Organizer and their immediate family members, specially defined as their father, mother, spouses and children;
  - PDB station dealers and Crew PETRONAS and their immediate family members, including their father, mother, spouses and children;
  - Employees of advertising and promotional agencies for PDB and their immediate family members, including father, mother, spouses and children.
  - Employees of Setel Ventures Sdn. Bhd.(“Setel”), employees of advertising and promotional agencies for Setel and their immediate family members including father, mother, spouses and children

### CAMPAIGN MECHANICS

1. Every spend of **RM30 and above** in a single transaction receipt with any Hong Leong Bank Visa Credit OR Debit card at any PETRONAS stations in Malaysia will entitle for ONE (1) entry; for example: -
  - a) **Example 1:** Participant who spend RM30 on fuel in a single transaction at PETRONAS station using Hong Leong Bank Visa Credit card, will obtain one (1) entry.

- b) **Example 2:** Participant spend RM90 on fuel and Kedai Mesra items in a single transaction at PETRONAS station using Hong Leong Bank Visa Debit card, Participant will obtain three (3) entries.
2. Every top up of RM30 in a single transaction via the Setel application with any Hong Leong Bank Visa Credit OR Debit to get one (1) entry for the running of the prizes.
  - a) **Example 3:** Participant top up RM30 on Setel application using a Hong Leong Bank Visa Credit card in a single transaction, Participant will obtain one (1) entry.
  - b) **Example 4:** Participant top up RM100 on Setel application using a Hong Leong Bank Visa Debit card in a single transaction, Participant will obtain three (3) entries.
3. No contest and registration forms are required for this Campaign.
4. Participants who linked their Mesra card to their Setel account will also earn Mesra points when they pay for their petrol purchases via the Setel application using Hong Leong Bank Cards. Any reversed or cancelled transaction shall excluded from eligibility.
5. By the end of the Campaign period, winners will be selected by the Organizer via computerized selection system, witnessed by the appointed committees from PDB, VISA, Setel and PDB's internal auditor. The Organizer's decision on all matters relating to this Campaign (including the selection of winners) shall be final and binding. No correspondence relating to selection of the winner(s) shall be entertained.
6. The winner(s) will be contacted either by the Bank, the Organizers and/or their representative via telephone. The winner(s) will be asked ONE (1) skill-testing question and upon answering correctly only the winner(s) are entitled to win the prize(s).
7. In the event winner(s) is unreachable via telephone, the Organizer shall reserve the right to select another winner.
8. The Organizer has the sole and absolute discretion in determining the eligibility to participate in the Campaign and/ or to receive the prizes. If the Organizer discover, at any time, whether during or after the Campaign Period that any Participants has failed to comply with the terms and conditions contained herein, the Organizer shall reserve the right to disqualify the cardholder from participating in the Campaign and or receiving the prizes.

#### **UNCAPTURED TRANSACTION**

1. In the event during the Contest Period, Participants who top-up their Setel account using their Hong Leong Bank Visa Credit OR Debit Cards but the transactions are not captured for any reason whatsoever, Setel reserves the right to exclude the transaction amount in the running of the Contest.
2. Nonetheless, Setel will on best effort basis subject to the transaction(s) captured by Setel application to enable the Participants to be eligible for the running of the Contest prizes.

## PRIZES

1. Each winner can only win ONE (1) prize from this Campaign.
2. Details of the Prizes are as follows: -
  - **Grand Prize x 1 winner:** Mercedes-Benz C200 Avantgarde
  - **Consolation Prize x 5 winners:** RM 3,000.00 worth of PETRONAS Gift Card for each winner

3. All winners recorded by the Organizer shall be final and conclusive. No correspondence relating to selection of the winners shall be entertained.
