

HONG LEONG PRIORITY BANKING REFERRAL PROMOTION

The Hong Leong Bank Berhad (97141-X) ("HLB")'s "**Hong Leong Priority Banking Referral Promotion**" ("**Promotion**") commences on 16 July 2018 and ends on 30 September 2018, both dates inclusive ("Promotion Period"), unless otherwise notified by way of posting on HLB's website at www.hlb.com.my ("**HLB's Website**").

Terms and Conditions
