

## SAFE DEPOSIT BOX PROMOTION: RENTAL FEE WAIVER FOR THE 1<sup>ST</sup> YEAR

*Last updated on 28 March 2019*

### PROMOTION PERIOD

The Hong Leong Bank Berhad's (97141-X) ("HLB") / Hong Leong Islamic Bank Berhad's (686191-W) ("HLISB") **Safe Deposit Box Promotion 2019: Rental Fee Waiver for the 1<sup>st</sup> Year** ("Promotion") commences on 10 April 2019 and ends on 30 June 2019, both dates inclusive ("Promotion Period"), unless notified otherwise.

### TERMS AND CONDITIONS

The following sets out the terms and conditions applicable to the Promotion ("T&Cs"):-

#### ELIGIBILITY

1. The Promotion is open to all new and existing individuals and non-individuals, including Malaysian and non-Malaysian Residents ("Customers").
2. For the avoidance of doubt,
  - (a) New customers refer to Customers who have not rented a Safe Deposit Box ("SDB") with HLB or/and HLISB prior to the Promotion Period
  - (b) Non-individual Customers refer to associations, clubs, schools, societies, non-profit organizations, sole proprietors, partnerships, professional practices and companies duly registered or incorporated in Malaysia; and
  - (c) HLB and HLISB staff (whether permanent or on contractual basis) are excluded from participating in this Promotion.
3. The participating Current or Savings Account / Current or Saving Account-i ("CASA / CASA-i") for this Promotion are as follows ("Participating Accounts"):
  - (a) Hong Leong Basic Savings Account
  - (b) Hong Leong Savings Account
  - (c) Hong Leong Senior Savers Savings Account
  - (d) Hong Leong Harvest Savings Account
  - (e) Hong Leong Pay&Save Account
  - (f) Hong Leong SmartLink Account
  - (g) Hong Leong Top Yield Account
  - (h) Hong Leong One Account
  - (i) Hong Leong Basic Current Account
  - (j) Hong Leong Current Account
  - (k) Hong Leong Basic Savings Account-i
  - (l) Hong Leong Savings Account-i
  - (m) Hong Leong Multi-Tier Savings Account-i
  - (n) Hong Leong Pay&Save Account-i
  - (o) Hong Leong Current Account One-i
  - (p) Hong Leong Basic Current Account-i
  - (q) Hong Leong Current Account-i

The HLISB's Participating Accounts are deposit accounts based on Shariah principle of Tawarruq. For the avoidance of doubt, all Participating Accounts stated in Clause 3 above are eligible for protection by Perbadanan Insurans Deposit Malaysia ("PIDM").

4. The Customers' participation in this Promotion is subject to the T&Cs stated herein and the Terms and Conditions governing the hiring of SDB.

#### PROMOTION MECHANICS

5. Customers who rent a SDB at SDB branches as listed in Appendix 1 below ("Selected Branches") must:
  - (a) Deposit the amount as stated in the table below ("Minimum Earmark Amount") into the Participating Accounts during the Promotion Period; and
  - (b) Maintain the Minimum Earmark Amount for six (6) consecutive months ("Earmark Period") from the date the Minimum Earmark Amount was deposited into the Participating Account, in order for the customers to be entitled to the rental fee waiver for the first year:

6. All deposits must be "New Funds" only. For the avoidance of doubt, "New Funds" are defined as:
  - (a) Cash, interbank GIRO, new funds received via telegraphic transfer from other banks, local cheque or banker's cheque issued by other banks which are deposited into the Participating Accounts; and
  - (b) Proceeds arising from the redemption of equity, unit trust funds, bonds / sukuk and / or Hong Leong Invest Safe during the Promotion Period that are re-deposited into the Participating Accounts
7. The following shall NOT be considered as "New Funds":
  - (a) Maturing Fixed Deposit or Fixed Deposit-i ("FD / FD-i") or premature withdrawal of any existing FD / FD-i account;
  - (b) Intra bank transfer of funds, i.e. transfer of funds from another HLB / HLISB's to Participating Accounts, FD / FD-i or General Investment Account ("GIA"); and
  - (c) Inter-branch transfer within HLB and HLISB including third (3rd) party transfer.
8. Customers who have fulfilled the criteria as set out in Clauses 5, 6 and 7 above shall be referred as "Eligible Customers".
9. For the avoidance of doubt, the Promotion is only for valid on the first year Annual Rental Fee and for subsequent year(s), the original Annual Rental Fee will be applicable.
10. This Promotion is valid on a first-come, first-served basis. Notification will be given in the event any or all of the SDB are fully occupied by posting on the HLB's website at [www.hlb.com.my](http://www.hlb.com.my) / HLISB's website at [www.hlisb.com.my](http://www.hlisb.com.my) ("HLB's Website / HLISB's Website").
11. Each SDB shall have two (2) sets of keys, namely the A key which shall be kept by HLB/HLISB and B key which shall be delivered to the Eligible Customers on payment of a deposit and the rental.
12. Eligible Customers are required to open or nominate a CASA / CASA-i maintained with HLB / HLISB under the name of the Eligible Customers ("Nominated CASA / CASA-i") for the purpose of debiting the subsequent Annual Rental Fee (in the event that the rental period is more than a year) and the key deposit as and when the same shall become due and payable.
13. In the event that the Eligible Customer does not have a CASA / CASA-i, the Eligible Customer is required to open a CASA / CASA-i on the day of SDB hiring, failing which the Eligible Customer shall not be qualified to participate in the Promotion.
14. In the event the CASA / CASA-i Placement is cancelled, removed (in part or in full) or released within the Earmark Period for whatever reasons, customer shall be charged with the annual rental fee at the original price.
15. The SDB is subject to the terms and conditions governing the hiring of SDB stipulated by HLB/HLISB.

16. This Promotion is NOT valid with any other on-going promotions offered by HLB / HLISB from time to time.

## **GENERAL**

17. By participating in this Promotion, Customers agrees:

- (i) to have read, understood and to be bound by the T&Cs herein and the Terms and Conditions governing the hiring of SDB;
- (ii) that HLB's / HLISB's decision on all matters relating to the Promotion shall be final, conclusive and binding on all Eligible Customers and no further correspondence and / or appeal to dispute HLB's / HLISB's decision shall be entertained;
- (iii) to access HLB's Website / HLISB's Website at regular time intervals to view the T&Cs of the Promotion and ensure to be kept up-to-date on any changes or variations to the T&Cs; and
- (iv) to be liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in the Promotion.

18. HLB / HLISB reserves the right:

- (i) at any time with twenty-one (21) calendar days' prior notice to add, delete, suspend or vary the T&Cs contained herein, either wholly or in part at HLB's / HLISB's discretion by way of posting on the amended T&Cs on HLB's Website / HLISB's Website, or in any manner deemed suitable by HLB / HLISB;
- (ii) to replace the Offer with alternative offers of similar value at its absolute discretion, by way of posting on HLB's Website / HLISB's Website or in any other manner which HLB / HLISB deems practical, in order to give prior notice to Customers
- (iii) to disqualify any Customers for any reason whatsoever as HLB / HLISB may in its absolute discretion deemed fit, from participating in the Promotion without assigning any reason thereof; and
- (iv) to forfeit the Offer in the event that there is non-compliance with the T&Cs stated herein and the Terms and Conditions governing the hiring of SDB and any appeal to HLB's / HLISB's such decision shall not be entertained

19. The T&Cs herein and the Terms and Conditions governing the hiring of SDB shall be read as an entire agreement. In the event of any discrepancy between the T&Cs herein and the Terms and Conditions governing the hiring of SDB, the specific T&Cs herein shall prevail to the extent of such discrepancy.

20. In the event of any discrepancy between the T&Cs herein and any advertising, promotional, publicity and other materials relating to or in connection with the Promotion, the final T&Cs on HLB's Website / HLISB's Website shall prevail.

21. The T&Cs shall be governed by and construed in accordance with the laws of Malaysia and the Customers agree to submit to the exclusive jurisdiction of the Courts of Malaysia.
