### **Organizer & Qualifications**

#### b. <u>How to Participate (2): via Whoop app (downloadable from Play</u> Store for Android)

- Register in Whoop App (one time registration)

  - i. Take a photo of the Proof of Purchase;
  - ii. Answer the contest question and the necessary info.
  - iii. RETAIN: TRANSACTION SLIP (original) as proof of purchase
