HONG LEONG OVERDRAFT FACILITY SECURED BY UNIT TRUST (ODUT) – CNY 2020 PROMOTION

PROMOTION PERIOD

The Hong Leong Bank Berhad's [193401000023 (97141-X)] ("HLB") "Hong Leong Overdraft Facility Secured By Unit Trust – CNY 2020 Promotion" ("Promotion") commences on 08 January 2020 and ends on 30 March 2020, both dates inclusive ("Promotion Period"), unless notified otherwise.

TERMS & CONDITIONS

The following sets out the terms and conditions applicable to the Promotion ("T&Cs").

ELIGIBILITY

- 1. The Promotion is open for participation by all new or existing HLB customer who are Malaysian citizens or non-Malaysian citizens but have obtained Permanent Resident status in Malaysia and reside in Malaysia for more than 182 days ("Customers") and aged between 18 and 65 years old.
