

### **HLB HOP HOP HUAT TERMS AND CONDITIONS**

The 2023 HLB Hop Hop Huat ("Contest") is a contest organized by Hong Leong Bank Berhad (193401000023 (97141-X)) ("HLB") which commences on 5 January 2023 at 00:00 hours (12:00 AM) and ends on 1 February 2023 at 23:59 hours (11:59 p.m.), both dates inclusive ("Contest Period"), unless otherwise notified.

# **Terms and Conditions**

1) The following sets out the terms and conditions applicable to the Contest ("T&Cs"):-

#### Eligibility

- 2) This Contest is open to all Malaysian individuals irrespective of whether they are customers of the Bank or otherwise ("Participants").
- 3) In order to be eligible for this Contest, all requirements must be fulfilled in accordance with the Contest Mechanics below.

### **Contest Mechanics**

4) Participants are required to log in to the contest microsite at <a href="https://www.hlbhophophuat.com">https://www.hlbhophophuat.com</a> using a valid email to play the game according to the gameplay instructions ("Game") as stated on the contest microsite.

#### **Contest Prize Winners Selection**

For each Contest Week, five (5) Grand Prize winners based on the top five (5) highest Games scores and twenty (20) Consolation Prize winners based on 6<sup>th</sup> to 25<sup>th</sup> top Games scores will be selected to win the Campaign Prizes.
